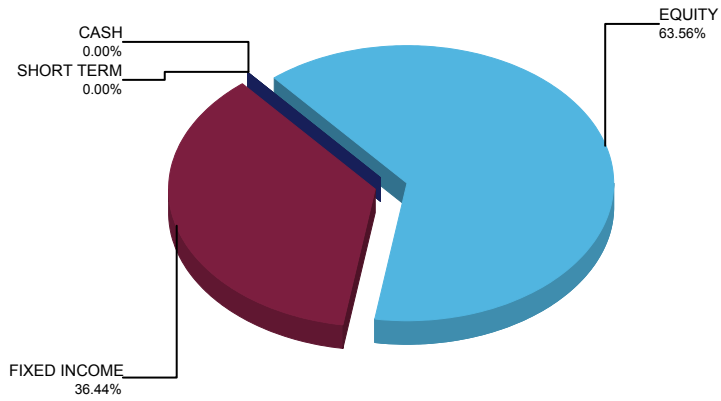

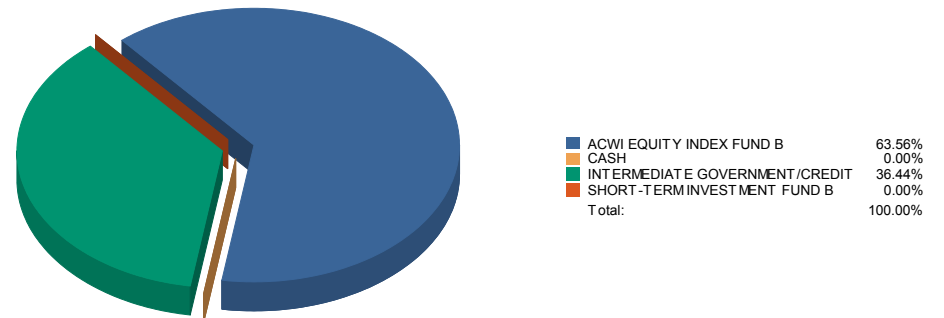
Account Composition
