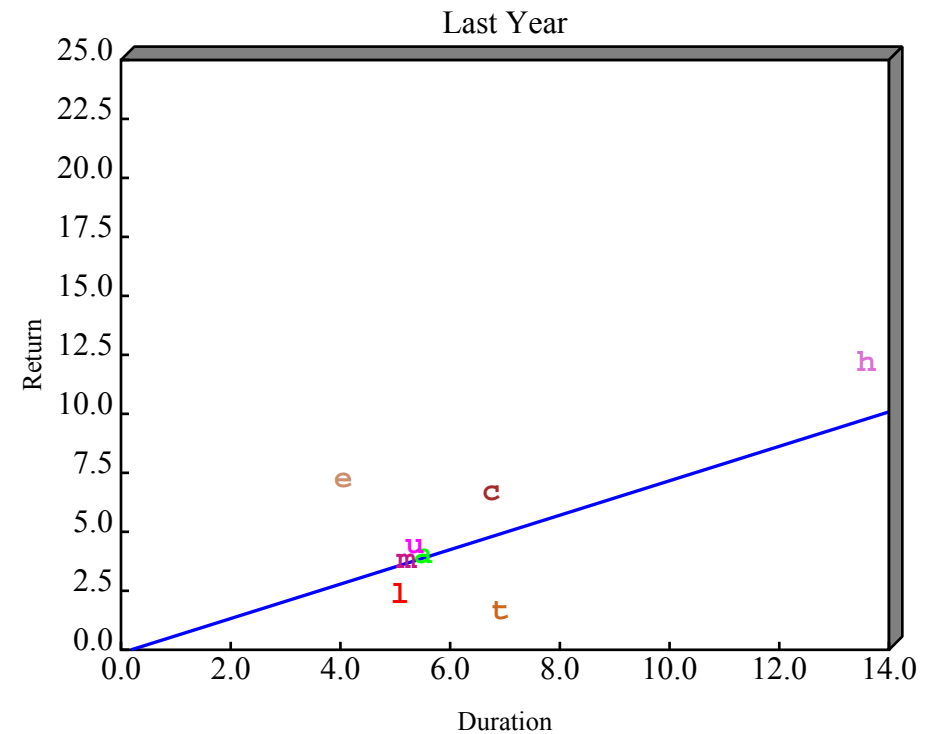
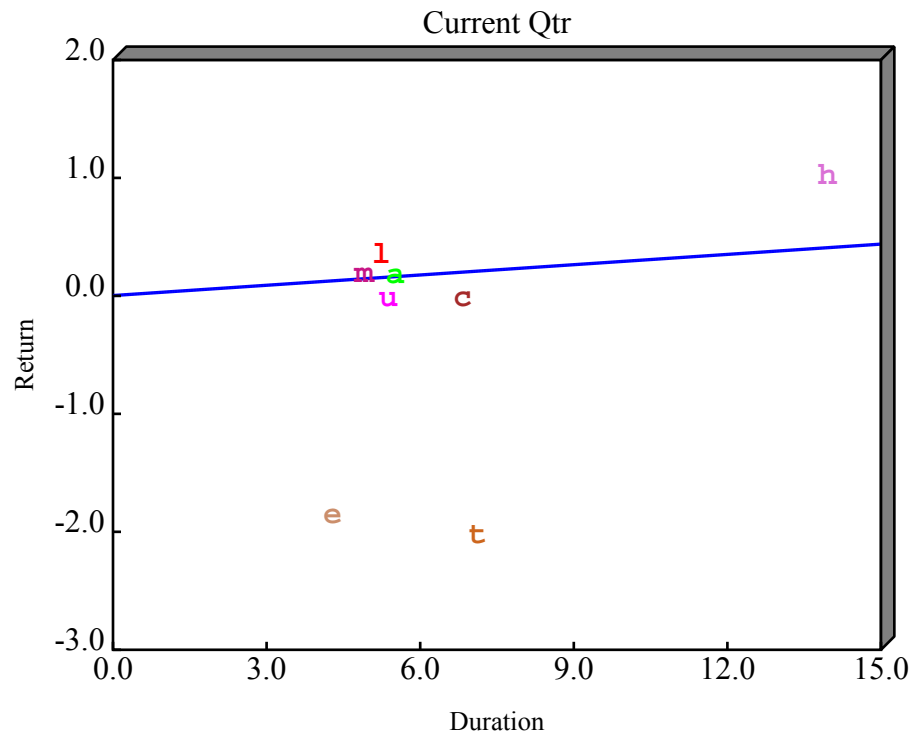
Relative Return

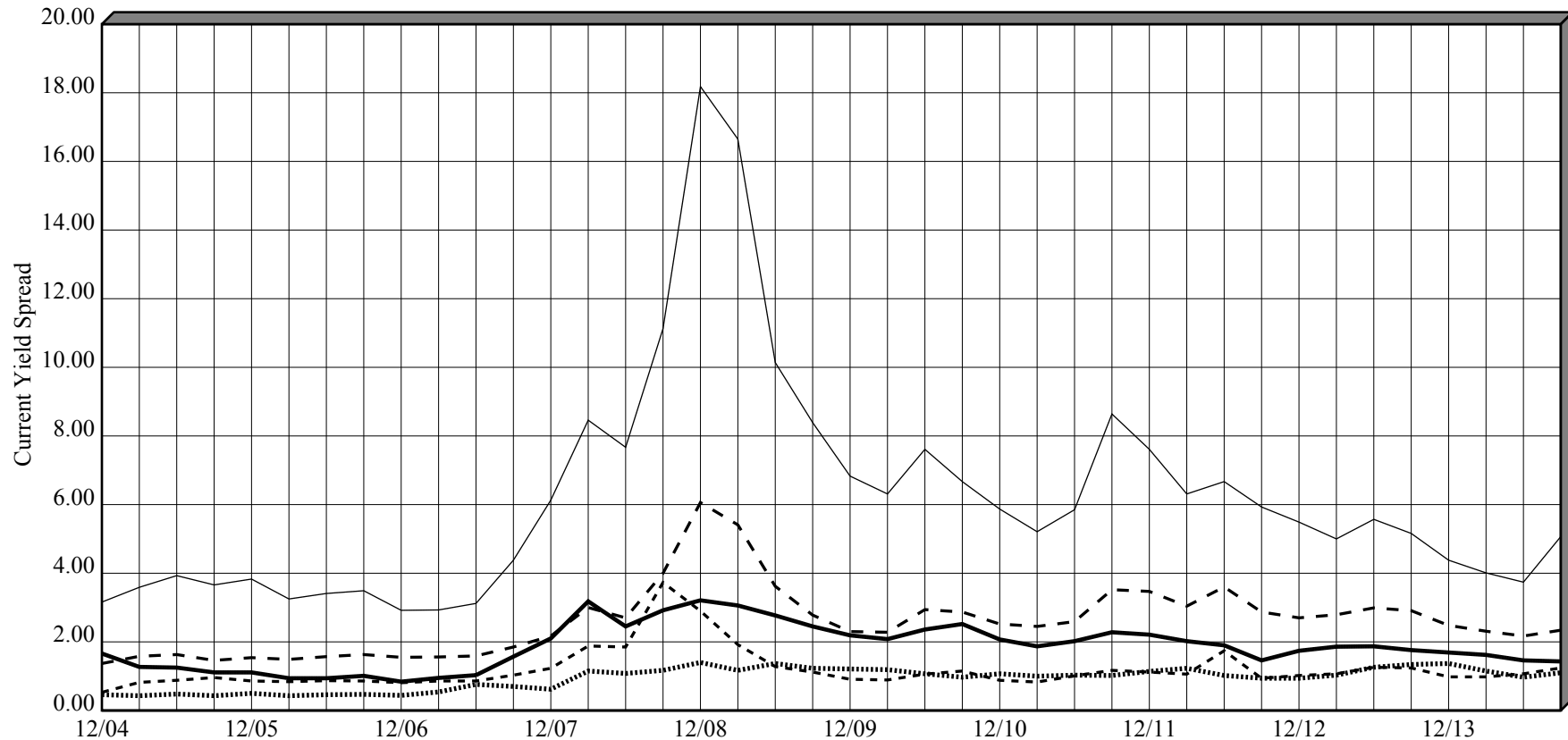

Historical Spread Comparison to Treasuries As of 9/30/14

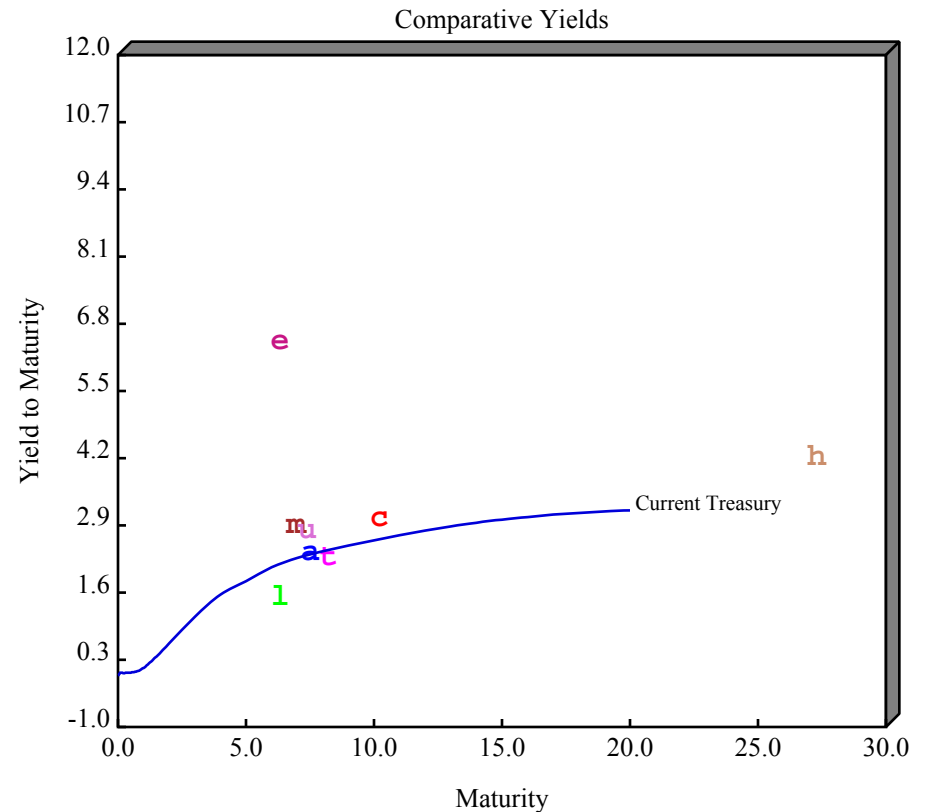
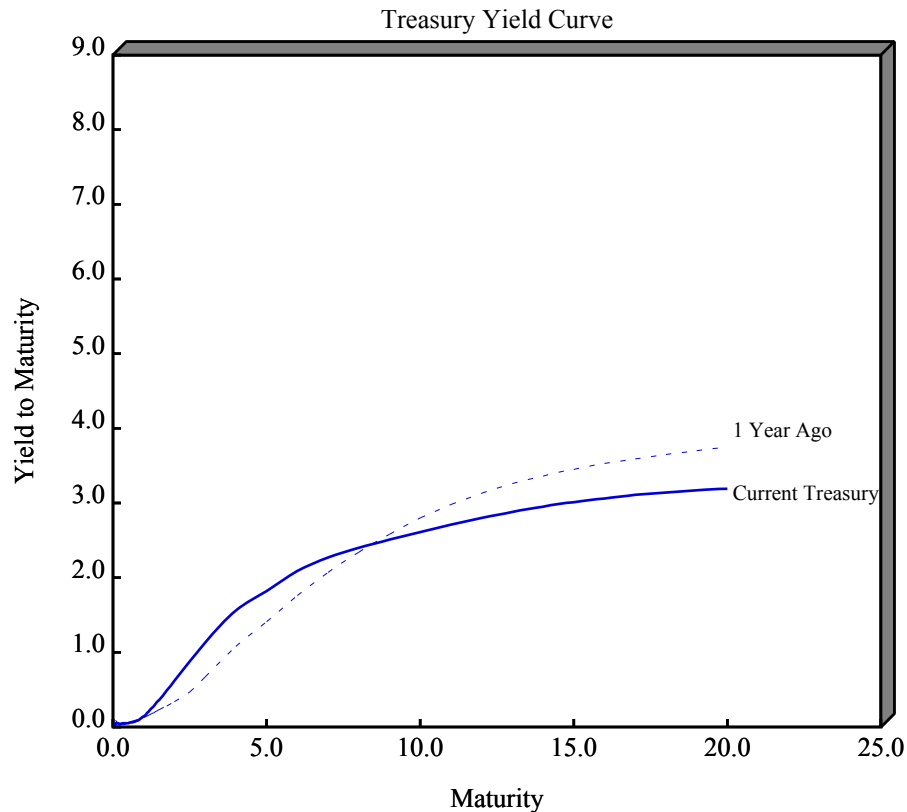

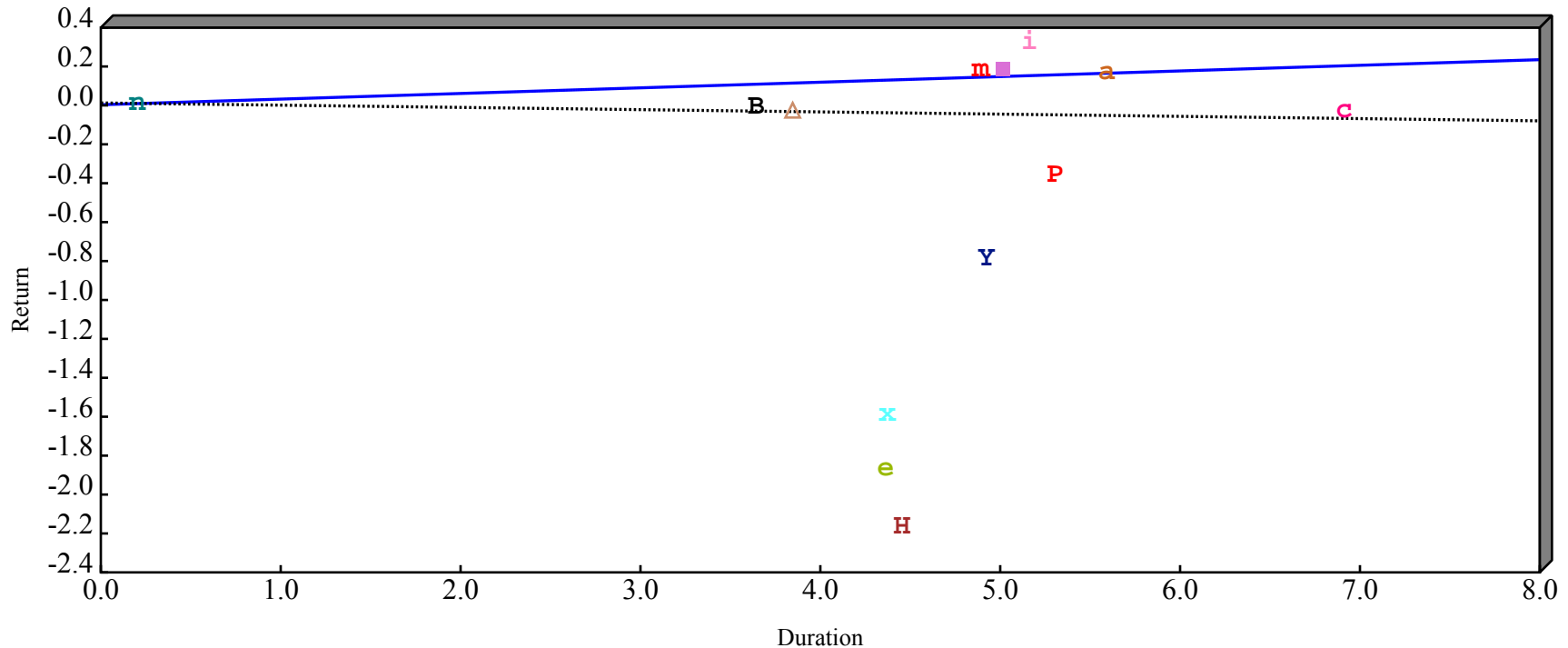

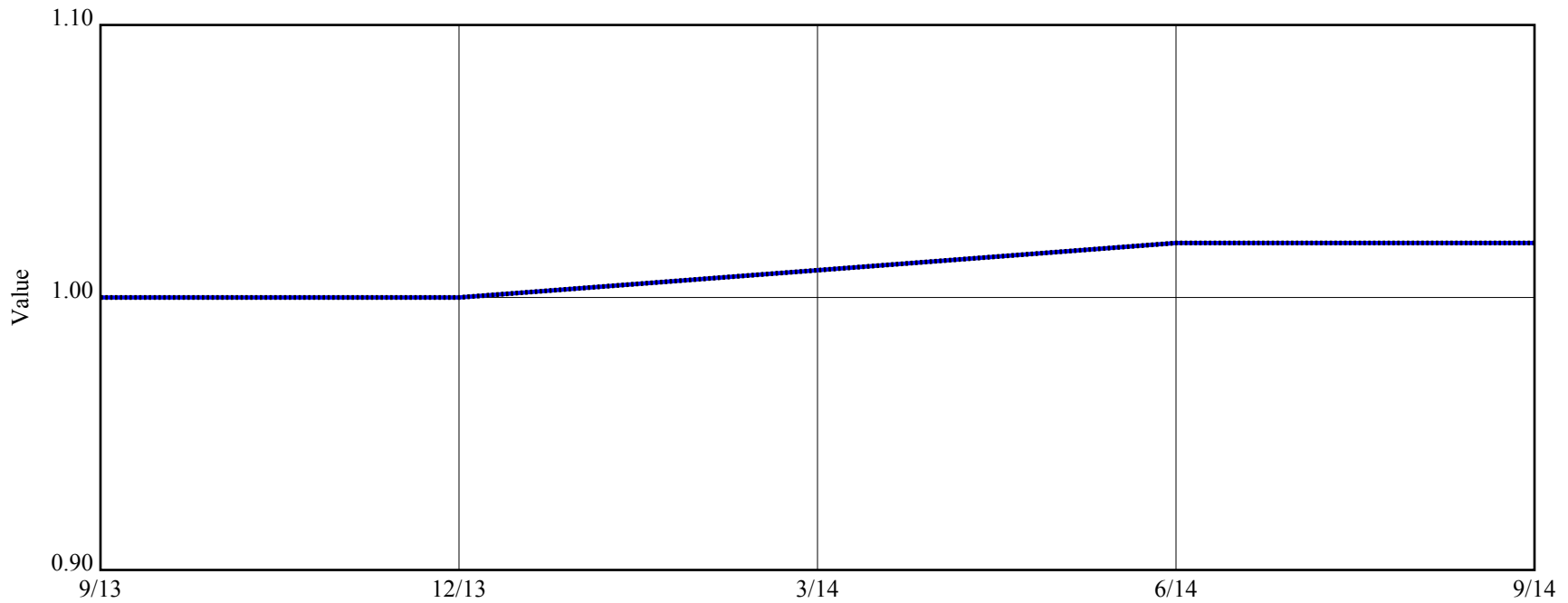
Wilcop Total Returns of Fixed Income Portfolios

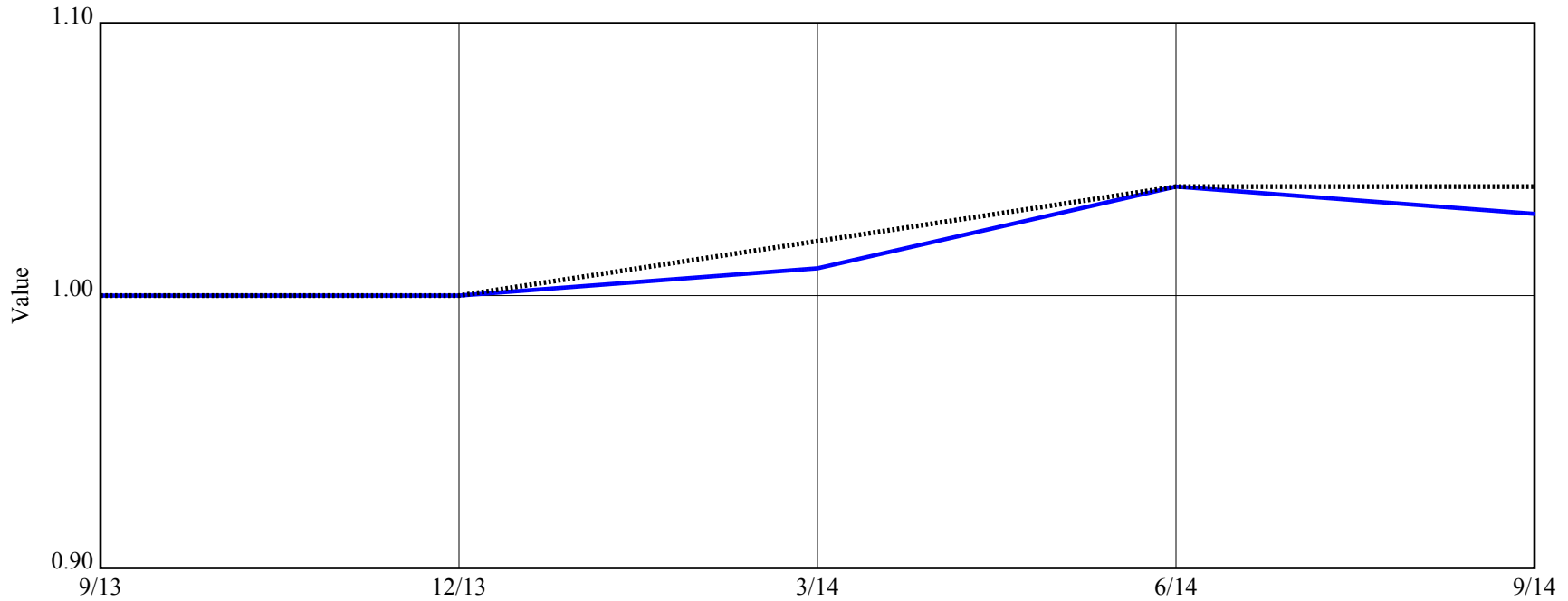

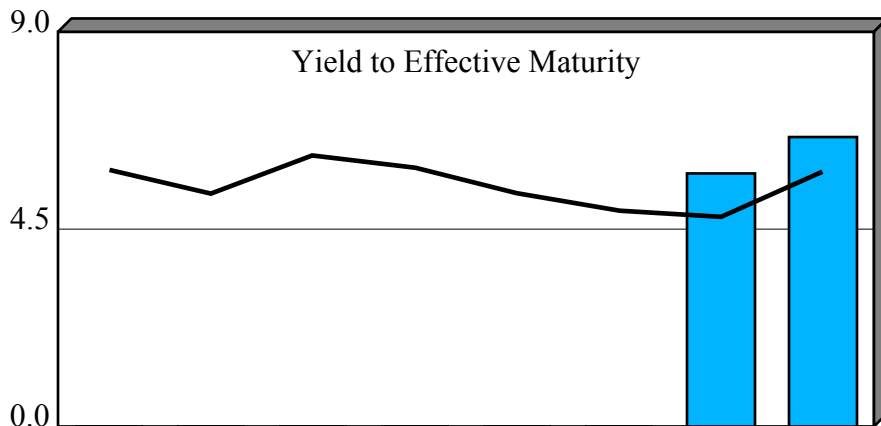
Hotchkis & Wiley High Yield Fund vs. ML US High Yld. BB/B Const.



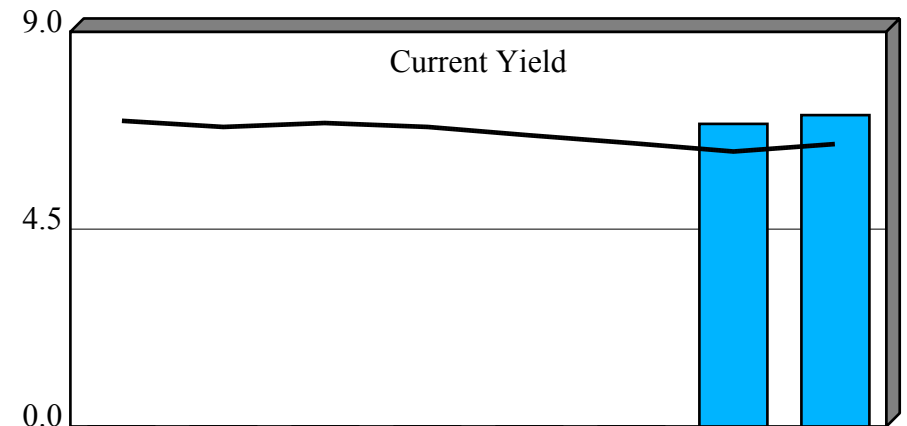
