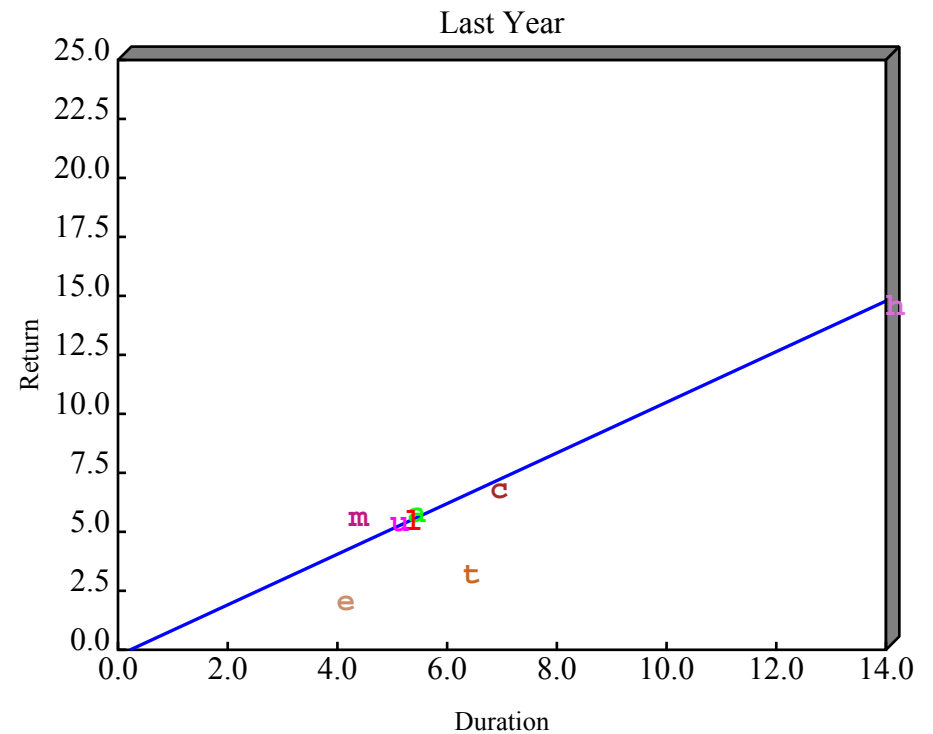
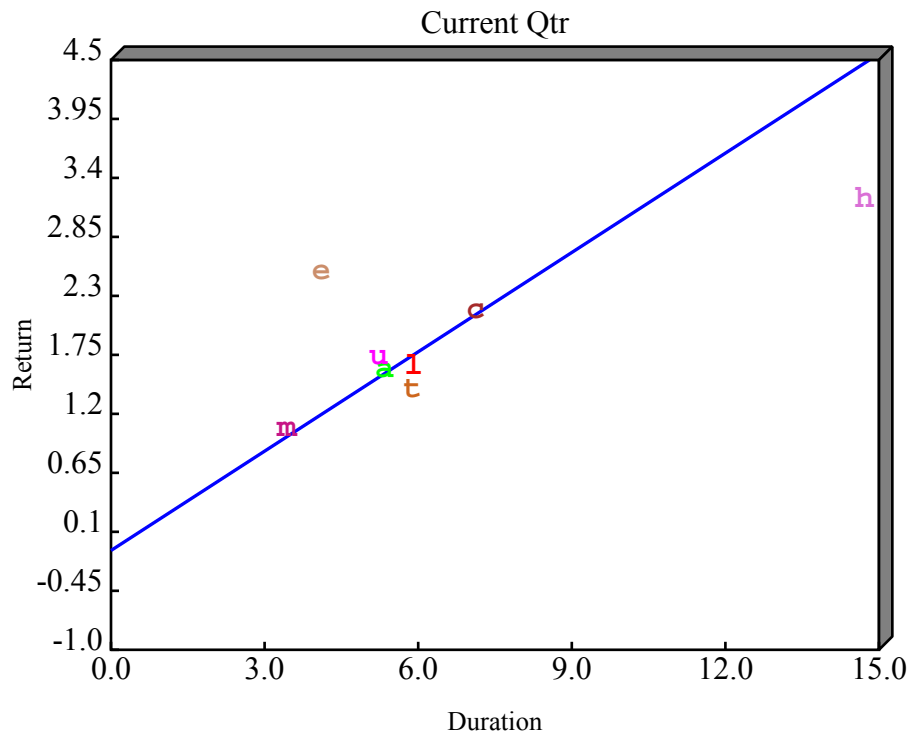
Relative Return

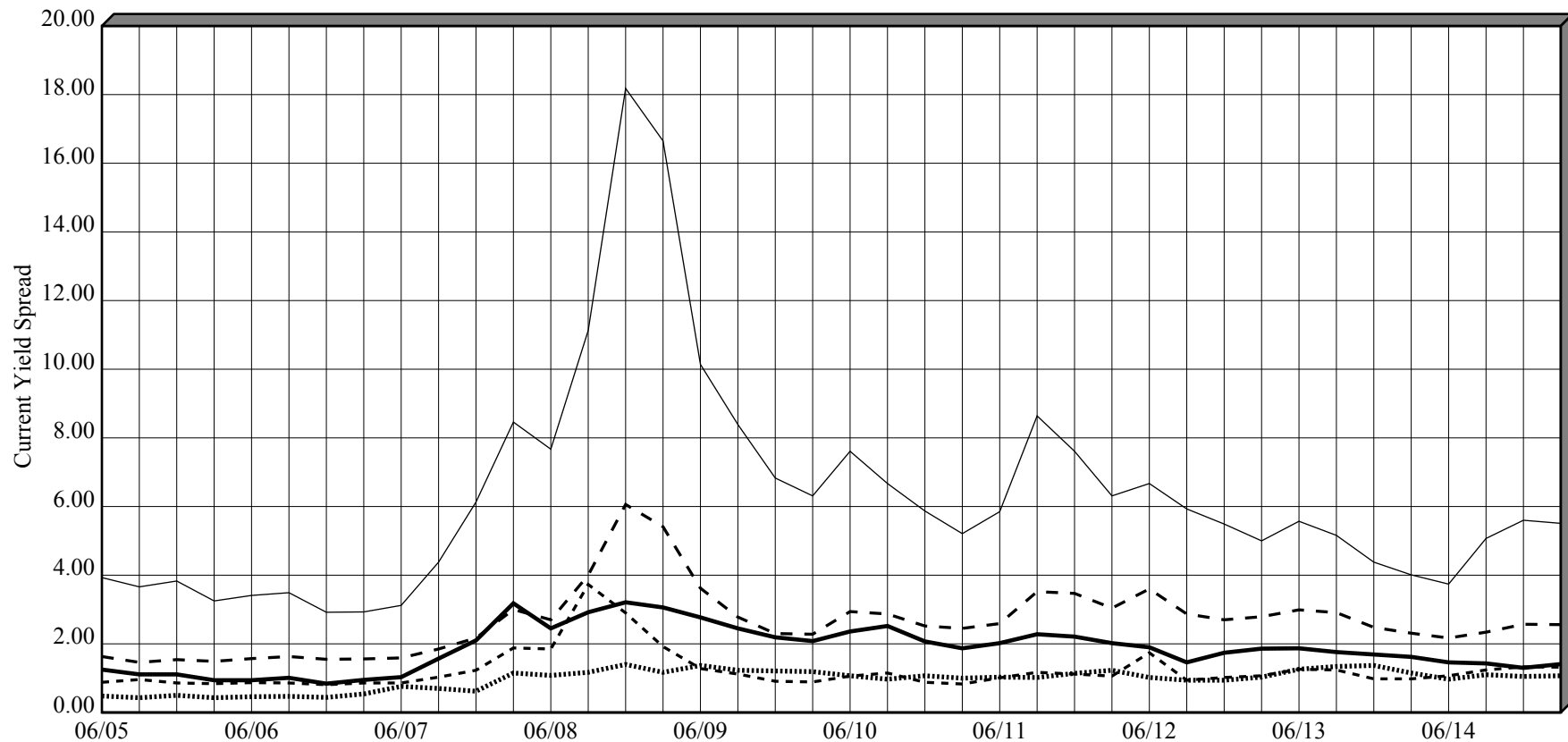

Historical Spread Comparison to Treasuries As of 3/31/15

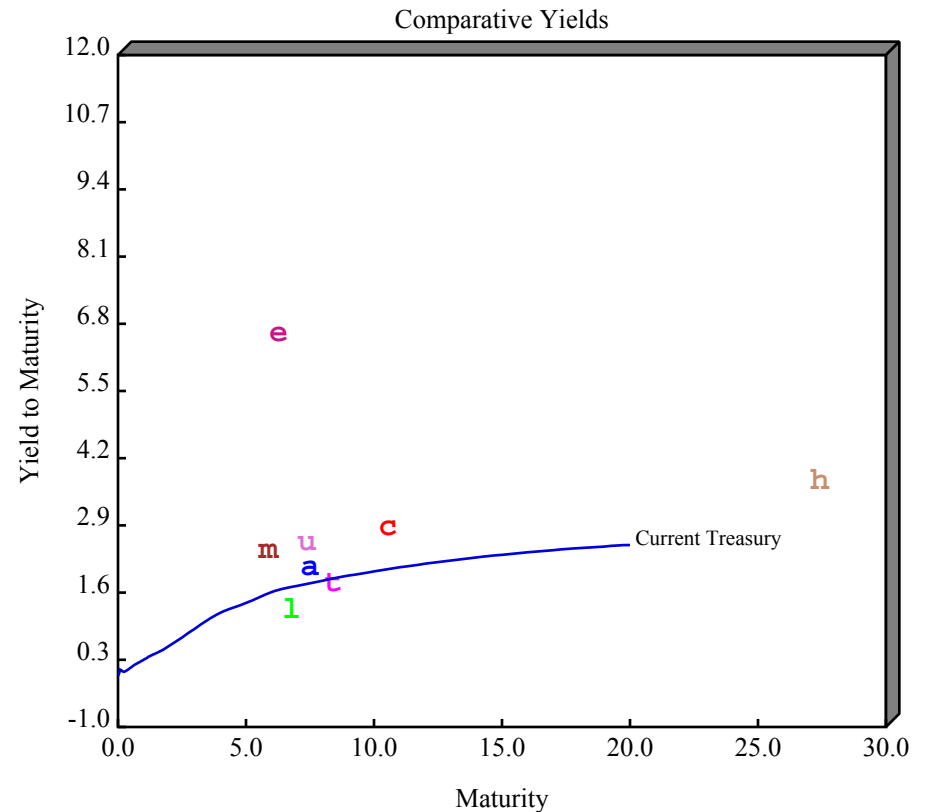
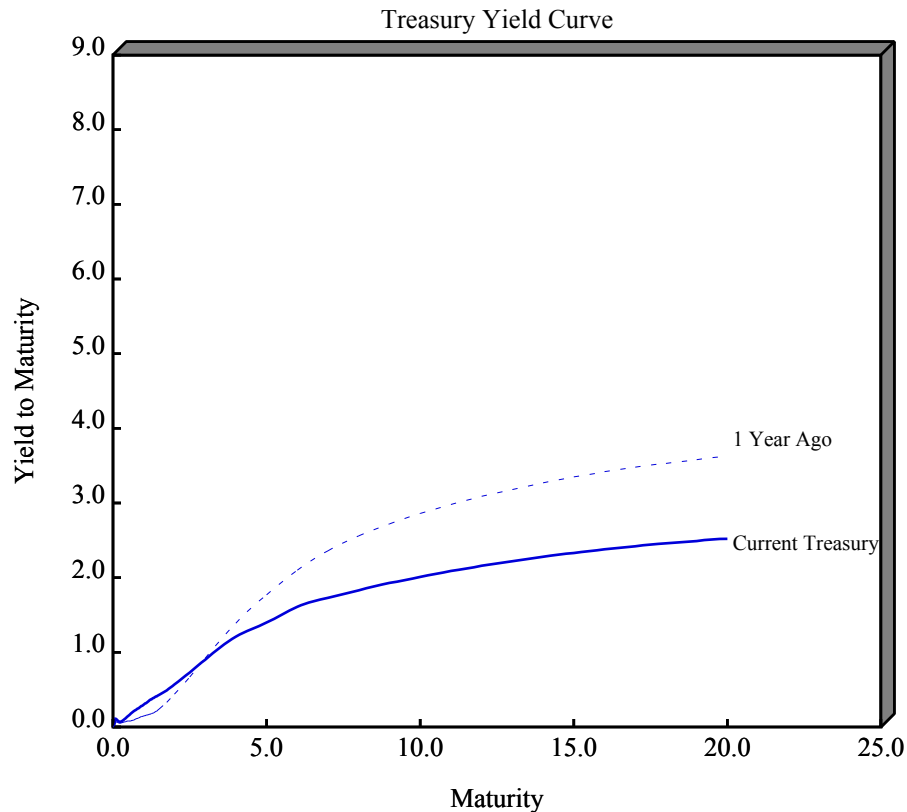

Yield Spread To Treasuries As of 3/31/15

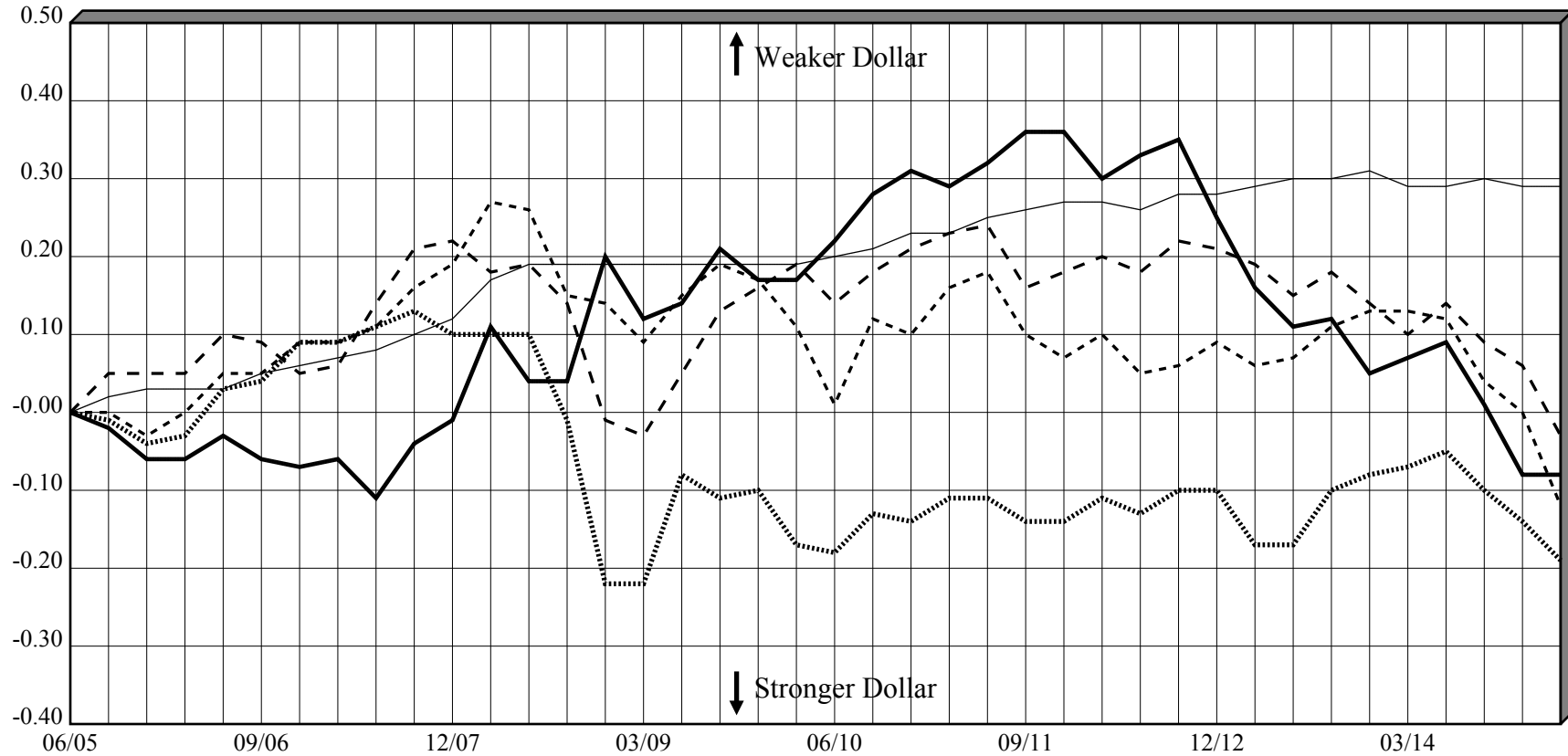

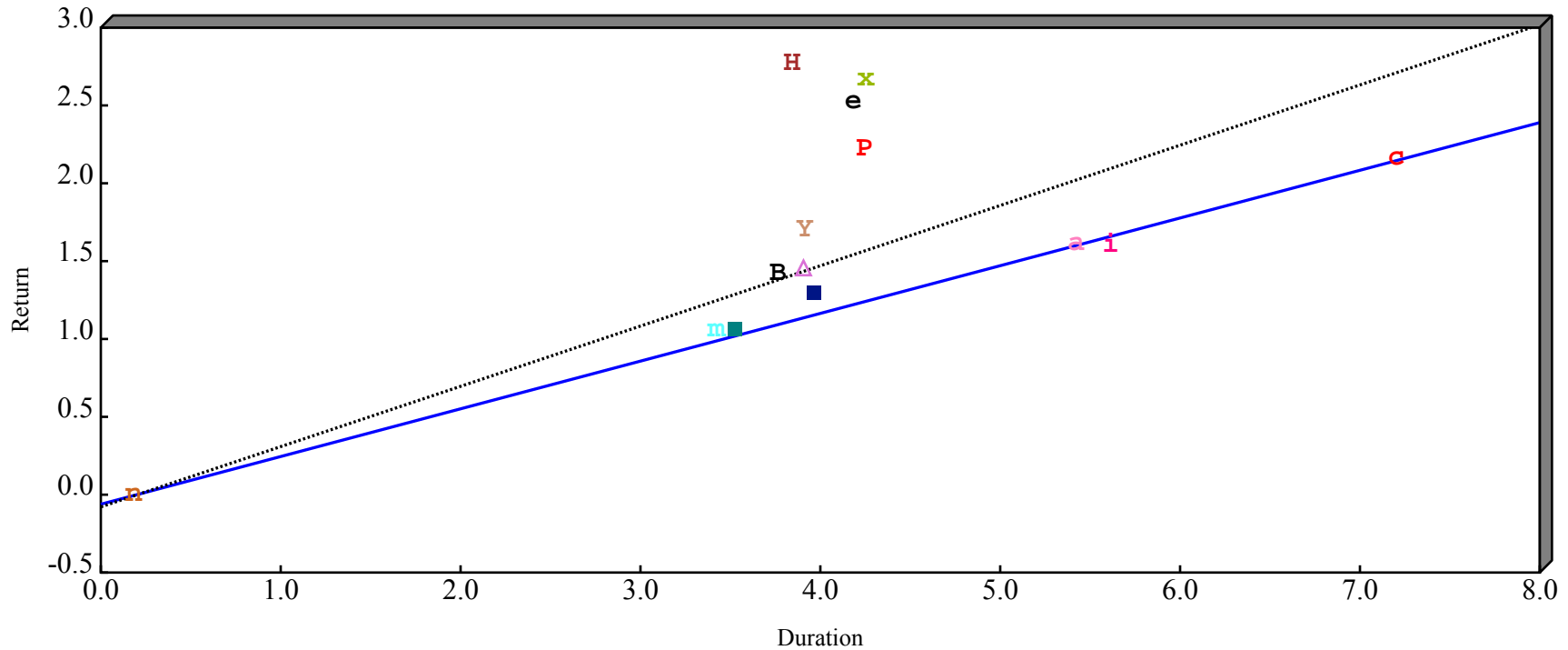

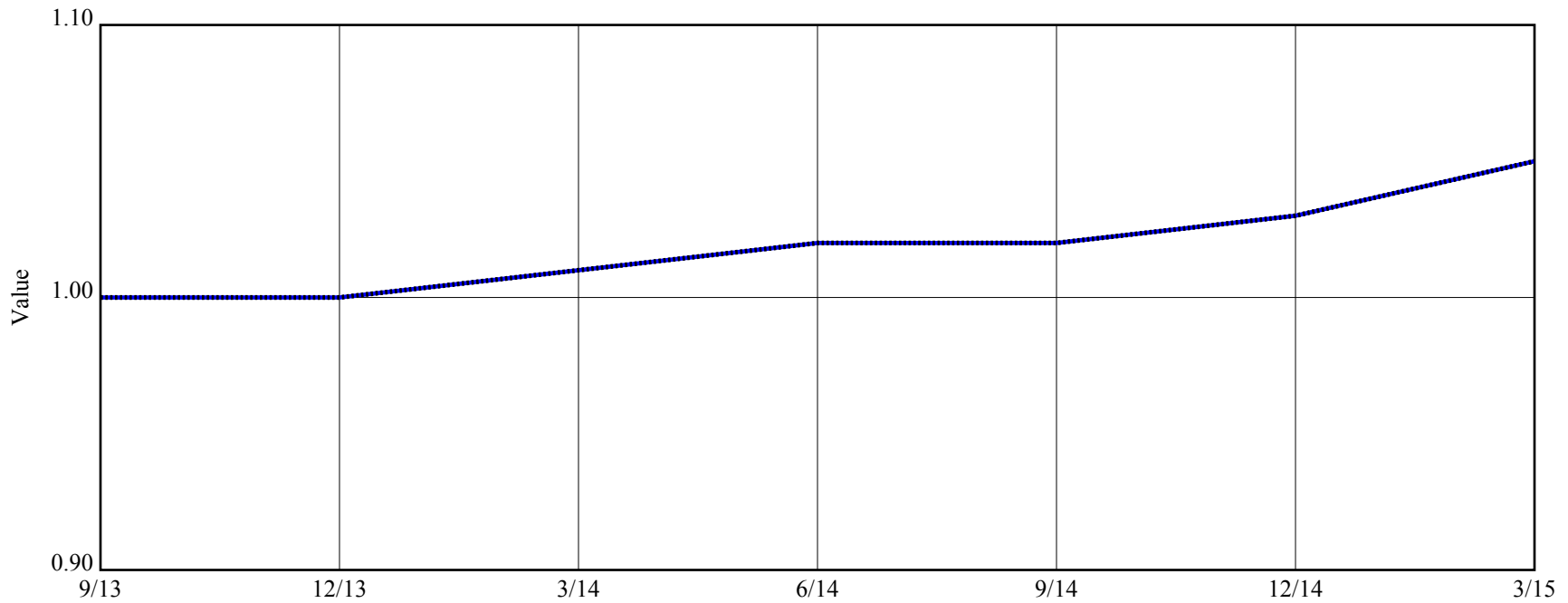
Wilcop Total Returns of Fixed Income Portfolios
