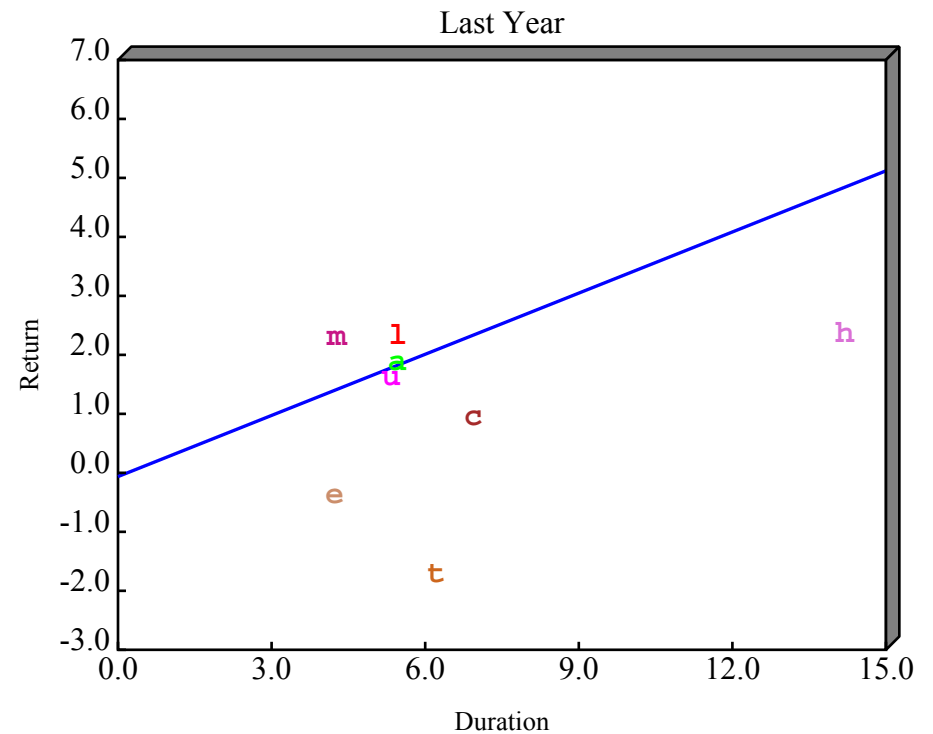
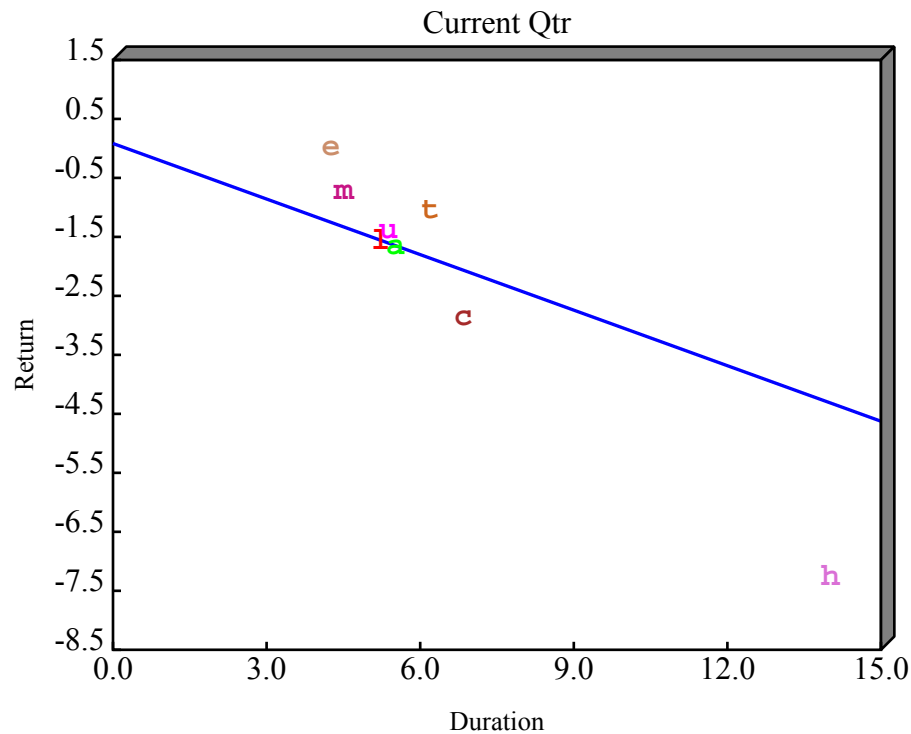
Relative Return

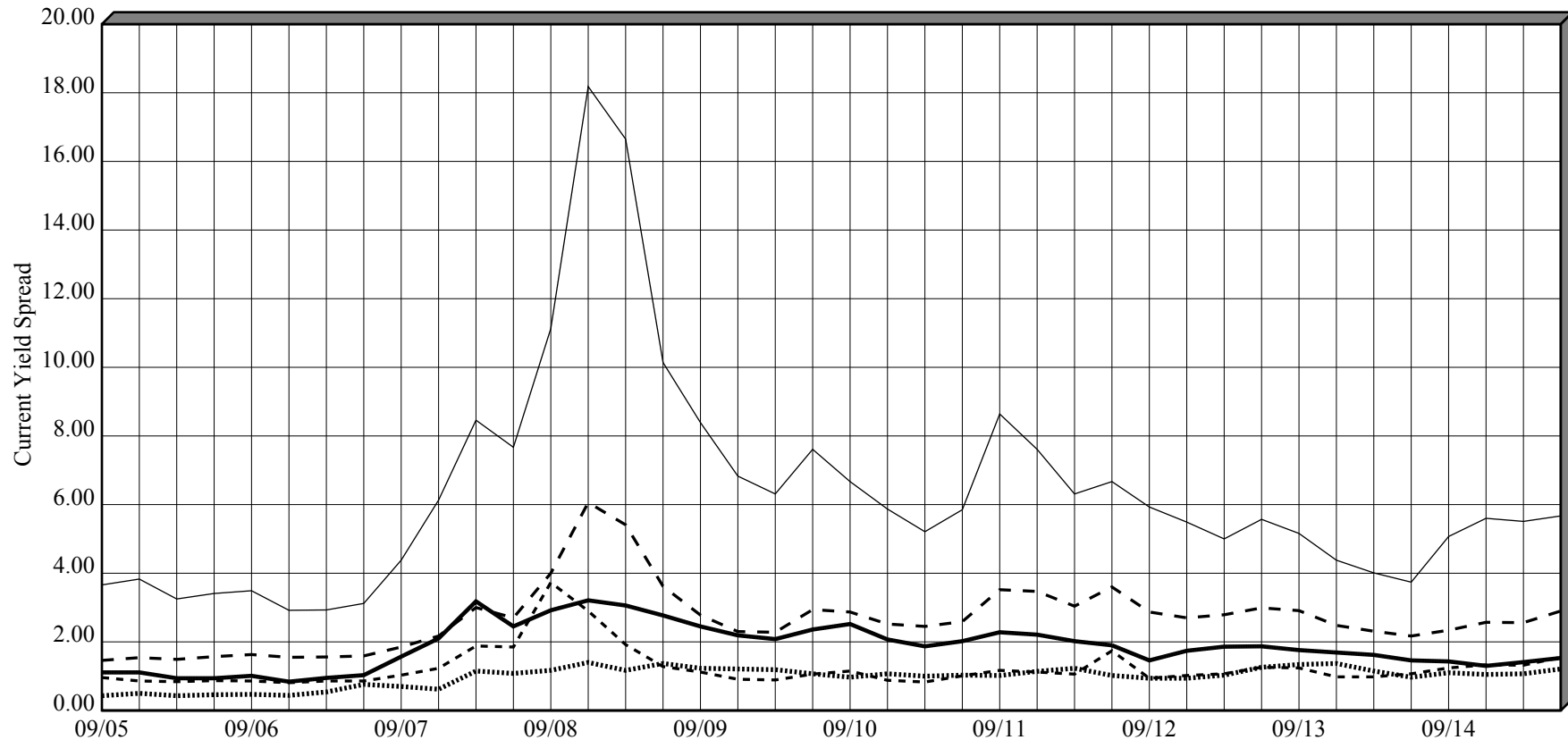

Historical Spread Comparison to Treasuries As of 6/30/15

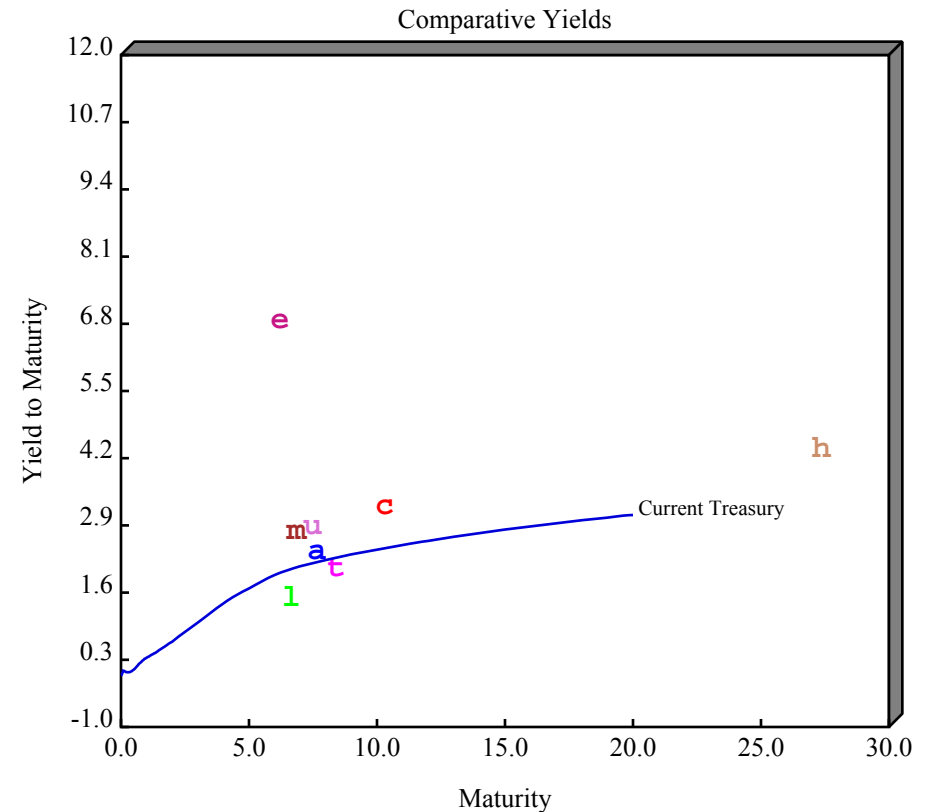
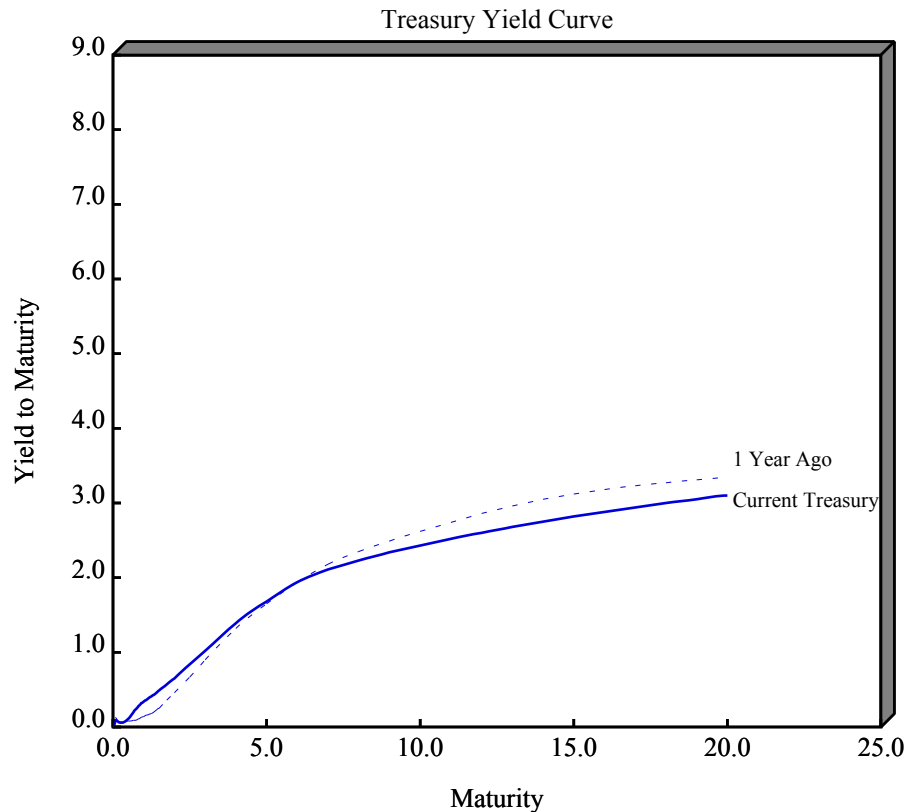

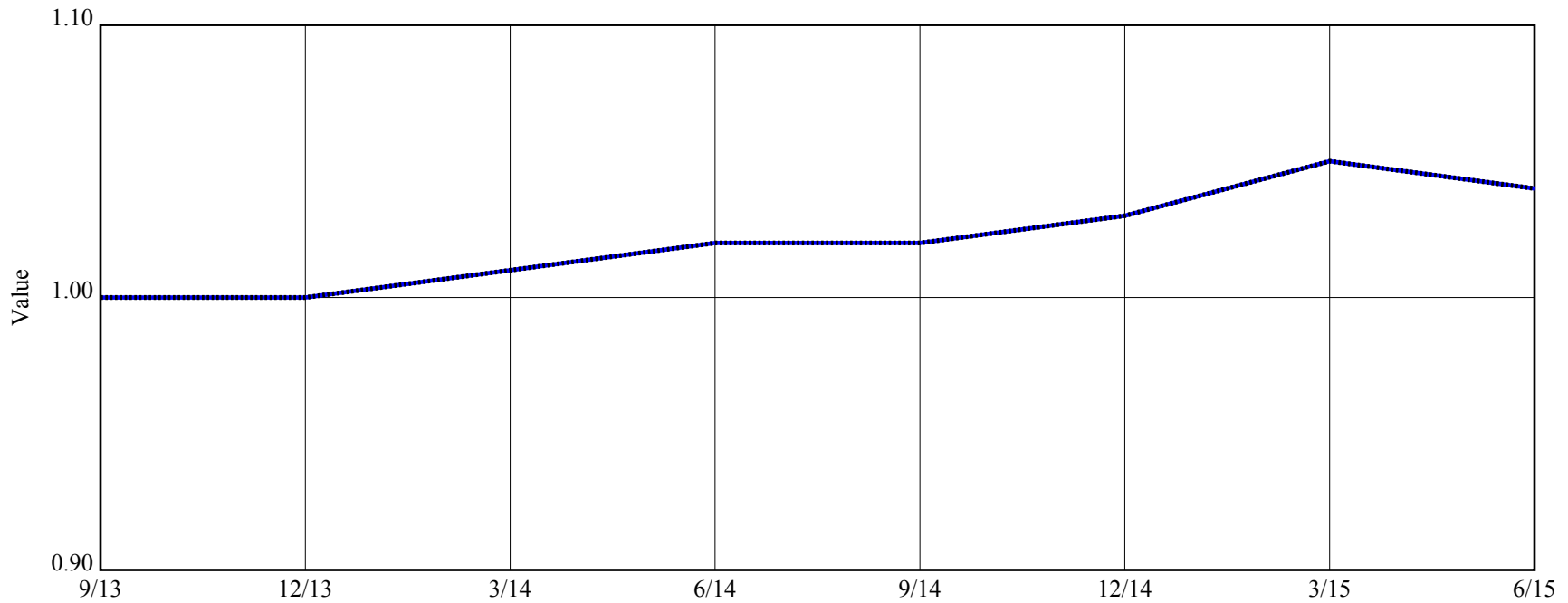
Wilcop Total Returns of Fixed Income Portfolios
