Dear Mr. Speaker and Mr. President:

This is to inform you that I have signed into law, with the exception of several disapproved parts, House Bill 19-196, SS1, CCS1 entitled, "to make appropriations for the operations and activities of the Government of the Commonwealth of the Northern Mariana Islands, its agencies, instrumentalities, and independent programs, and to provide budget authority for the government corporations for Fiscal Year 2017, "which was passed by the 19th Northern Marianas Commonwealth Legislature".

N.M.I Const. Art. III §IX (a) provides a timeline and penalty provision when the Governor and the Legislature must submit and pass a balanced budget. I am mandated as Governor in a new administration to submit a balanced budget to the legislature on or before May 1st; the Legislature is mandated to pass a balanced budget by October 1st; and if no budget is passed by the first day of the fiscal year, there shall be a Government shutdown where no funds will be expended by the General Fund, except for essential services. I applaud the swift action of the 19th Legislature to ensure that the budget for Fiscal year 2017 reaches my desk with sufficient time for my review.

While I am approving this bill into law, I am compelled to address several sections that I have disapproved, or identified as likely problematic, unenforceable, unclear and inconsistent with other provisions of law. There are also several provisions that if implemented would result in unfairness in relation to other activities of the government. As such, the following is my overview and comments on H.B. 19-196, SS1, CCS1 in numerical order as the sections appear in the bill.

Section 201

There is a discrepancy in the estimated revenues for PL 13-38 Cigarette Excise Tax to Tobacco Control as shown in Section 201 II(a)(1) and the projected amount for Tobacco

Control in Section 713 (a). Clarification should be made in the variance of \$803,878, between the two amounts.

Nonetheless, I thank the members for the inclusion of my recommendation in this section to allow the Commonwealth Election Commission to receive advance allotments in preparation for the upcoming mid-term elections, including activities requiring one-time payments to receive advance allotments as well as to the Scholarship Office to process financial assistance awards to students both on island and off island.

Section 202

Section 202 (c) suspends the funding approved by P.L. 19-49 to the Office of Grants Management and State Clearing House. This provision would hinder the capability of the office to provide the necessary compliance and oversight of federal grants received by the CNMI government. Due to the significance of federal funding to critical government projects and services, I am disapproving this provision.

Section 301

Section 301(i) reflects the redirection of funds from the Marianas Visitors Authority (MVA) and I will continue to caution the Legislature against repeated actions that may negatively impact the operations and activities of MVA. Tourism is one of our key sources of revenues and although the redirected funds would fund beautification projects, it would also impede on MVA's strategic plan to competently promote the CNMI. To strengthen MVA's ability to respond to the growth in our tourism industry, I hereby veto Section 301, page 15, lines 22-24 and Section 301, page 16, lines 1-19.

Section 501

I thank the Legislature for the continued flexibility extended to the Governor in Section 501 by authorizing the 100% reprogramming authority for the appropriations under the Executive Branch but also to include the Independent Programs. This flexibility is necessary enabling the Governor to respond when warranted.

Section 601

This section which gives flexibility to the Mayors of the First and Second Senatorial District to reprogram funds appropriated for utilities is not sound fiscal management policy. CUC brought three separate lawsuits in the CNMI Superior Court because of the inability of the Commonwealth and its agencies to timely make payment of its CUC billings. Payment of CUC's billings must be a priority. I would have been inclined to approve this provision if it had included a requirement that the outstanding utility payments be paid first and that any balance remaining may be reprogrammed. In the absence of such a requirement, the second sentence of Section 601 is **hereby vetoed in its entirety.**

Section 604

The 1% fee allocated to the Public Auditor, this provision dictates any remaining funds at the end of the fiscal year shall be applied to the Department of Finance for the purpose of strengthening our information technology (IT) capabilities. This measure is unenforceable due to the expiration of FY 2017 budgetary authority at the end of the fiscal year; therefore, without such authority there can be no application of any remaining funds to the Department of Finance. The provision should be revised to provide

flexibility allowing at least 30 days for the Secretary of Finance to reserve funds for the intended purpose.

Section 605

A comprehensive review and amendments to the Salary Compensation Act should be considered to address changes in compensation specifically with the changes in the minimum wage and for those affected by Section 605, including Public Law 17-80, as amended by P.L. 18-5. The ad hoc fashion in which the Legislature sought to suspend the application of various provisions within HB 19-196, SS1, CCS1, sends a strong signal that it is time to perform such a comprehensive review.

Several provisions in this legislation creates inequities among classified employees in the Civil Service System by adjusting base salaries across all branches of government for only selected employees. The action of the Legislature invites potential litigation for the arbitrary selection of specific employees that may be in violation of the federal equal employment opportunity laws. Funding adjustments to the designated department/division are already included in the allocations set forth in Schedule A. It would be proper to allow the department heads to exercise discretionary authority in applying fair and equitable changes to eligible employees. Therefore, I am disapproving the provisions specified in Table 1 reflecting Schedule B and Schedule B-1 allocation. Please refer to Table 1, reflected in *Enclosure 1*.

Section 705

Section 705(h) raises ambiguity as to the status of municipal employees funded by the casino license fee allotted to the First Senatorial District, and whether they will remain as municipal employees or become employees of the Commonwealth Government. Because of this deficiency, **I am disapproving subsection (h).**

Section 706

Section 706 (b) suspends Public Law 17-80 with respect to the recruitment and hiring of certain positions. P.L. 17-80 provides the necessary statutory structure for the hiring of the specified classified positions for the entire Commonwealth Civil Service System. If the Legislature wishes to exclude these positions from Public Law 17-80, it should do so in a Commonwealth-wide review of job classifications. **Therefore, I am disapproving this provision**.

Section 706 (j) increases the number of position allocation by 23. Because the new positions are unfunded, I caution the Mayor against filling them as it will result in unauthorized deficit spending in violation of Commonwealth law.

Section 710

Sections 710 (k) (1) and 710(k) (2) provide specific instructions to the Northern Marianas Sports Association (NMSA). Although created by Commonwealth law, NMSA is established as a private not-for-profit corporation, whose affairs and operations are run by a governing board as set forth in its bylaws. As such, no number of positions should be assigned to NMSA, nor should the Legislature specify how much the employees should earn. Those decisions should be left to the discretion of NMSA's governing board. I am disapproving this provision in the interest of protecting NMSA's private not-for-profit designation.

Section 710 (m) does not correspond to Section 301 (f), which sets the Commonwealth Public Utilities Commission (CPUC) budget authority at \$2. Section 710(m) states that the CPUC may spend in excess of \$135,000. I disapprove Section 710 (m) as it sets no limitation in CPUC's budget authority.

Section 713

Section 713 (d), this Administration fully supports the required development of a plan to implement U.S. P.L. 110-229, Section 6.a.6, prior to obligation and disbursement of funds.

Section 801

The inclusion of the 5% Civil Service wage increase in Section 801 should have been contingent upon the passage of H.B. 19-003.

Section 803

The appropriation for judgment and settlements will finally provide relief for those who have unpaid government judgements and settlements. Although funds are made available in Section 803 to satisfy the main judgments, the Commonwealth remains obligated to pay any accrued post-judgment interest.

We have included with this message *Enclosure* 2, which summarizes the appropriation in H.B. 19-196, SS1, CCS1, and displays the distribution of funds based on government activities and uses for Fiscal Year 2017.

I urge the legislature to take note on the comments in this transmittal and act promptly to address the issues raised. This bill except with the vetoed portions becomes Public Law 19-68. Copies bearing my signature are forwarded for your reference.



The Bill was not referred to a House Committee.

THE BILL WAS PASSED BY THE HOUSE OF REPRESENTATIVES ON FIRST AND FINAL READING, AUGUST 25, 2016;

without amendments and transmitted to the THE SENATE.

The Bill was referred to the Senate Committee on Fiscal Affairs.

THE BILL WAS PASSED BY THE SENATE ON FIRST AND FINAL READING, SEPTEMBER 16, 2016; with amendments in the form of H. B. 19-196, SS1 and was returned to THE HOUSE OF REPRESENTATIVES.

The House of Representatives rejected the Senate amendments and the Bill was sent to Conference, which submitted Conference Committee Report 19-2.

THE BILL WAS FINALLY PASSED ON SEPTEMBER 24, 2016.

AN ACT

TO MAKE APPROPRIATIONS FOR THE ACTIVITIES OF THE GOVERNMENT OF THE COMMONWEALTH OF MARIANA NORTHERN ISLANDS, ITS AGENCIES, INSTRUMENTALITIES, AND INDEPENDENT PROGRAMS, AND TO PROVIDE BUDGET AUTHORITY FOR GOVERNMENT CORPORATIONS FOR FISCAL YEAR 2017: AND FOR OTHER PURPOSES.

Be it enacted by the Nineteenth Northern Marianas Commonwealth Legislature:

CHAPTER 1. PRELIMINARY PROVISIONS.

Section 101. Short Title. This Act may be cited as the "Appropriations and Budget Authority Act of 2017".

Section 102. Purpose. This Act appropriates local funds for the operations and activities of the Government of the Northern Mariana Islands, its agencies, instrumentalities, independent agencies and political subdivisions, and provides authority for government corporations for Fiscal Year 2017 commencing October 1, 2016 and ending September 30, 2017.

- (g) "Number of Positions" (NOP) means the maximum number of persons that may be employed, pursuant to Article X, Section 7 of the Commonwealth Constitution but does not include Workforce Investment Agency, substitute teachers, summer trainees, teacher aides, physicians, licensed professional nurses and licensed allied health providers working part-time and paid only for instructional time, student teacher trainees, or short term specialized instructors, such as visiting artists, performers, writers, and the like. For purposes of this exception, "part-time" means employment not exceeding 40 hours in any biweekly pay period, and "short-term" means not more than 90 instructional days employment within the Public School System during the fiscal year.

The CNMI Scholarship Office and the Commonwealth Election Commission may receive advance allotments for its scholarship award program and election costs; respectively.

Section 202. <u>Suspension of Earmarked Funds</u>. Except for debt service obligations and other earmarking of funds as permitted in Section 201 of this Chapter, the earmarking, reservation, commitment, allotment, or allocation of funds pursuant to the following public laws are hereby suspended for Fiscal Year 2017:

- (a) Public Laws 15-5 and 14-54 (Non-resident Worker Fund Fees to NMC and PSS and 10% of Gaming Jackpot Tax to PSS); and
- (b) 4 CMC § 1508(a) and (b) (10% of General Fund poker fees to the Human Resources Development Fund [WIA] and 50% to the Retirement Fund).
- (c) Except for the appropriation of \$264,142 provided in Schedule A of this Act under BU 1043, the required funding of the Office of Grants Management pursuant to P.L. 19-49 is suspended for FY 2017.

CHAPTER III.

GOVERNMENT CORPORATIONS AND DESIGNATED AGENCIES/ACTIVITIES

Section 301. Appropriation and Budget Authority. Pursuant to 1 CMC § 7206 and as provided herein, budget and expenditure authority for the following activities is hereby approved. Expenditures in excess of the budget authority approved herein for agencies to which public funds are appropriated shall not be incurred or committed, and hiring in excess of the number of positions authorized by this Act is prohibited, unless authorized by a legislative joint resolution in accordance with Section 7, Article X of the N.M.I. Constitution.

-budget is modified and shall allocate \$600,000: \$200,000 for the Mayor of Saipan for eleanup, beautification projects, and foreign student exchange program; \$100,000 for the Division of Parks and Recreations for cleanup, maintenance and beautification of parks. tourist and recreational sites; \$250,000 for the Department of Public Works to redesign and -reconstruct the roads at Hotel Street/Western Garapan to alleviate the traffic and parking -congestion; and \$50,000 for repairs and renovation of the Commonwealth Museum.

The Mayor of Saipan shall submit all requests for payments for the cleanup, beautification projects, and foreign student exchange program to the Marianas Visitors Authority for payment.

The Department of Lands and Natural Resources, Division of Parks and Recreation, shall submit all requests for payments, for the cleanup, maintenance_and beautification of parks, tourist and recreational sites, to the Marianas Visitors Authority for payment.

The Department of Public Works shall submit all requests for payments, for the -redesign and reconstruct of the roads at Hotel Street/Western Garapan to alleviate the traffic and parking congestion and allow for additional parking spaces, to the Marianas Visitors Authority for payment.

The Department of Community and Cultural Affairs shall submit all requests forpayments, for repairs and renovations of the Commonwealth Museum, to the Marianas Visitors Authority for payment.

Section 302. Prior Certification of Funds. No contract shall be entered into with the Commonwealth or any government entity therein without first receiving from the Secretary of the Department of Finance certification that lawful and sufficient funds have

been appropriated. This section shall not apply to the Public School System and the Northern Marianas College.

Section 303. Reporting Requirement. The expenditure authorities of the foregoing activities listed in Section 301 shall submit to the presiding officers of the Legislature, at the end of each quarter, a fund status report on the expenditures for personnel and operations of each government entity, and the payments of the public auditor's fee, for the quarter ended and, if applicable, year-to-date totals as of the close of the reporting period.

Furthermore, notwithstanding any provisions or laws to the contrary, all additional resources realized within the fiscal year outside of those specified and identified under this Act shall be reported to the Legislature for informational and appropriation purposes.

CHAPTER IV. ADMINISTRATION OF APPROPRIATED FUNDS

Section 401. Management of Funds. The expenditure of the funds appropriated and allocated under this Act shall be regulated and controlled by the Secretary of Finance so that no agency, department, instrumentality, program, or activity may expend the funds contrary to the law or fiscal management policies and practices of the Commonwealth. Provided further that, in addition to the report required under 1 CMC §7209, the Secretary of Finance shall submit within 30 calendar days at the end of each quarter, a fund status report on the expenditures for personnel and operations of each business unit funded in whole or in part by the General Fund for the quarter ended and, if applicable, year-to-date totals as of the close of the reporting period.

Section 402. Number of Position(s) (NOP) Ceiling. Employment Ceilings.

Pursuant to Article X, § 7 of the Commonwealth Constitution, the employment ceilings relative to the number of positions are hereby established as set forth in Schedule A.

Section 403. Expenditure Authority.

- (a) The distribution and expenditure of funds shall be in compliance with the fiscal expenditure authority that the listed agencies have pursuant to statute and the administrative provisions of this Act.
- (b) Except as provided in this Act, the funds appropriated pursuant to this Act shall be expended by the respective expenditure authority pursuant to 1 CMC § 7401.

CHAPTER V. REPROGRAMMING AUTHORITY

Section 501. Reprogramming Authority

- (a) Authority to reprogram appropriated funds shall be as provided under 1 CMC §§ 7402 and 7504, unless otherwise specified in this Act.
- (b) Except as provided herein, 1 CMC §7402(b) is suspended to provide the Governor with 100% reprogramming authority within the Executive Branch and Independent Programs. Pursuant to 1 CMC § 7402(e), all reprogramming shall be reported in writing to the Presiding Officers of the Legislature, Chairman of the House Committee on Appropriations and the Chairman of the Senate Committee on Fiscal Affairs within 30 days after the end of each quarter of the fiscal year. Such reports shall include a description of each item reprogrammed, the reason for each reprogramming, the change in the approved budget caused by the reprogramming, the cumulative amount of all reprogramming during the fiscal year, and such other information as may be requested by the chairmen. The

Governor shall submit to the presiding officers and chairmen an annual summary of all reprogramming activity within 60 days after the end of a fiscal year.

CHAPTER VI. SUPPLEMENTAL ADMINISTRATIVE PROVISIONS

Section 601. <u>Utilities</u>. The amount appropriated for the payment of utilities shall not be reprogrammed, nor shall other appropriations be reprogrammed for the payment of utilities, except for the purpose of covering increased utility costs due to rate increases. Provided, however, that the funds appropriated for utilities for the First and Second-Senatorial District may be reprogrammed by the respective Mayor for other purposes.

Section 602. <u>Hiring Restriction.</u> No new or vacant position shall be filled in the executive branch, except for positions which are essential for the delivery of public services as determined by the Governor. The Governor shall approve the filling of new and vacant position prior to the announcement of the position.

Section 603. NOPs – Vacant Holding Account. The NOP ceiling for the entire Executive Branch includes 50 NOPs which shall be allocated to a Vacant Holding Account in the Other Offices of the Governor and Lt. Governor, which may be filled by the Governor or Lt. Governor, subject to the following:

- (a) The NOPs shall be restricted to positions that are essential to the delivery of public services;
- (b) The Governor submits a quarterly report to the legislature on the utilization of these 50 NOPs as follows:
 - (1) Job title and job code
 - (2) Department to which the NOP is assigned

(4) Date of hire

Section 604. <u>Public Auditor's Fee.</u> Notwithstanding 1 CMC §7831, any remaining balance at the end of the fiscal year of the Public Auditor's Fee of 1% (one percent) of the total appropriations for each government agency's operations and activities shall be applied to the Department of Finance for the purpose of strengthening our information technology (IT) capabilities and to ensure our IT system is reliable and secure.

Section 605. Salary Cap Exemption.

- (a) 1 CMC § 8245(c) is hereby amended for fiscal year 2017 to increase the annual salary of the resident department heads of the First and Second Senatorial District to \$45,000.00. The resident department heads are responsible for the operations of all the divisions of each department and this salary exemption corresponds to their current duties and responsibilities;
- (b) 1 CMC § 28003 is hereby amended for fiscal year 2017 to increase the annual salary of the resident deputy commissioners of the Department of Fire and Emergency Medical Services for the islands of Rota and Tinian to \$45,000.00;
- (c) 1 CMC § 8245(f) is hereby amended for fiscal year 2017 to increase the annual salary of the special assistant for management and budget/CIP administrator to not less than \$62,000.00, which shall be taken from BU 1014; and
- (d) Director of Electronic Data Processing shall be paid a base salary of \$49,266.00 out of BU 1160 and Director of Procurement and Supply shall be paid a base salary of \$49,266.00 out of BU 1140.

Appropriations to the Municipal Council shall be divided and distributed equally to each member of the Municipal Council in separate accounts. Each Municipal Council member shall be the expenditure authority of funds distributed to him/her.

- (d) Rota Agriculture, BU 1412. From the funds appropriated for Personnel, one new NOP for a Conservation Coordinator and shall be paid a base salary as shown in Schedule B-1;
- e) Rota Fish and Wildlife, BU 1422. From the funds appropriated for Personnel, one new NOP for Conservation Inspector I shall be paid a base salary as shown in Schedule B-1;

(f) Rota Customs, BU 1152. From the funds appropriated for Personnel, one new NOP for a K9 Inspector and shall be paid a base salary as shown in Schedule B-1;

(g) Rota Parks and Recreation, BU 1442. From the funds appropriated for Personnel, one new NOP for Trades Technician I and shall be paid a base salary as shown in Schedule B-1;

(h) When vacancies occur in FY 2017 in the Office of the Mayor, the Mayor shall use the corresponding budgeted salary for the vacant positions to fund the municipal employees funded from the \$2,000,000.00 casino license fee for the First Senatorial District, subject to appropriation by the Rota Legislative Delegation.

Section 706. Second Senatorial District – Tinian & Aguiguan. The Number of Personnel and appropriations for personnel, operations, and utilities for the Second Senatorial District shall be as shown in Schedule A.

(a) Except as provided in this section, Mayor of Tinian and Aguiguan shall have authority to expend, obligate, encumber, otherwise commit or reprogram, all the funds appropriated to the Second Senatorial District. Appropriations to the Municipal Council shall be divided and distributed equally to each member of the Municipal Council in separate accounts. Each Municipal Council member shall be the expenditure authority of funds distributed to him/her. Additionally, in accord with the Superior Court's decision in the case of *Inos v. Tenorio*, the Mayors shall also have expenditure authority over resident government departments in the First and Second senatorial districts respectively unless the Governor revokes expenditure authority in a manner consistent with the Superior Court's holding in *Inos v. Tenorio*, to wit: expenditure authority over resident departments that are

primarily concerned with the delivery of public services can be revoked only on a prior showing of just cause, but the Governor has discretion to revoke expenditure authority over those departments that are primarily concerned with enforcing the law;

The sum of \$1,606,854.00 in Commonwealth Worker Fee Funds is to be administered by the Secretary of the Department of Labor in collaboration with the educational entities. The Secretary of Labor shall collaborate with partners such as the Northern Marianas College and the Northern Marianas Trade Institute (NMTI) to ensure funds are directed specifically towards the intent of the program.

Such funds shall not be used or reprogrammed for any other purpose other than what is specified pursuant to Public Law 110-229, Section 6.a.6 (Certain Education Funding). Prior to obligation and disbursement of funds, the Secretary shall develop a plan on implementation showing collaboration with the partners, indicating the partner's roles and anticipated outcomes. The Secretary of Labor shall provide accountability and transparency in administering this program by providing a quarterly expenditure report to the Administration and to the presiding officers of the legislature.

Section 714. Violations of Spending Limits.

(a) The expenditure of funds in excess of appropriations and reprogramming established by this Act is a violation of the Planning and Budget Act, 1 CMC § 6001 et. seq. Any government employee violating The Planning and Budget Act shall not be entitled to indemnification, defense or reimbursement under the Government Liability Act or any other Commonwealth Law.

CHAPTER VIII. ADDITIONAL SUPPLEMENTAL ADMINISTRATIVE PROVISIONS

Section 801. Civil Service Wage Increase. Except for the civil service employees whose salaries have been adjusted in Fiscal Year 2016 or whose salaries are adjusted as shown in Schedule B, all other civil service employees' salaries shall be increased by 5% to be funded with the Civil Service Wage Increase appropriation as shown in Schedule A, provided that the department reclassify those current employees at Step 12 to reflect the 5 percent increase pursuant to this section. Within 30 days of the effective date of this Act, the

Personnel Actions to take effect on October 1, 2016.

Section 802. Earmarked Cancer Fund. Pursuant to 4 CMC §1402(g)(2), out of the

expenditure authority of the affected civil service employees shall process the Notice of

\$1,333,500.00 earmarked for the Cancer Fund Special Account, Section 201(a)(3), the amounts listed below shall be transferred to the appropriate expenditure authority and shall be used for the following:

- (a) \$250,000.00, in addition to the P.L. 19-16 appropriation, shall be used for the CNMI Medical Referral stipends for patients and escorts on medical referrals outside of the Commonwealth. The expenditure authority shall be Director of the CNMI Medical Referral; and
- (b) \$100,000 shall be used for Rota Inter-island Medical Referral patients' lodging accommodations. The expenditure authority shall be the CHCC CEO.

Section 803. <u>Judgments and Settlements Against Government</u>. The amount of \$1,010,000.00 under BU 1623 shall be used to pay the final judgments and settlements, excluding interest: based on the following:

- (a) Judgments and settlements in the amount of \$150,000.00 and below shall be paid in full;
 - (b) Judgments and settlements above \$150,000.00 shall be paid proportionately;
- (c) The expenditure authority of the funds appropriated for the judgments and settlements against government shall be the Secretary of Finance in consultation with the Attorney General; and

(d) Any unencumbered appropriation in BU 1623 shall be deposited in a non-lapsing account for judgments and settlements against the government.

CHAPTER IX. GENERAL PROVISIONS

Section 901. Severability. If any provision of this Act, or its application to any person or circumstance, is held invalid, the invalidity does not affect other provisions or applications of the Act which can be given effect without the invalid provision or applications, and to this end the provisions of this Act are severable.

Section 902. Savings Clause. This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of this Act shall not have the effect of terminating, or in any way modifying, any liability civil or criminal, which shall already be in existence at the date this Act becomes effective.

Section 903. Effective Date. This Act shall take effect upon its approval by the Governor, or its becoming law without such approval.
