#### Market Commentary

Month Ended October 31, 2023

#### U.S. Economy and Markets

- The broad U.S. equity market was down in October as the FT Wilshire 5000 Index<sup>sм</sup> returned -2.66%, with a positive return of 9.50% for the year-to-date.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap Index<sup>™</sup> and the FT Wilshire Small Cap Index<sup>™</sup> returning -2.20% and -5.63%, respectively.
- Performance across most GICS sectors was negative in October. Utilities was the only positive sector for the month, while energy was the main laggard.

#### International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned -4.05% this month. The MSCI Emerging Markets Index also produced a loss in October, down -3.89%.
- The U.S. dollar strengthened versus advanced foreign economies during the month, resulting in the developed markets' local currency return being higher than those converted back to dollars.

#### Fixed Income & Real Assets


- Core bonds posted a loss of -1.58% in October as the 10-year U.S. Treasury yield rose 36 basis points.
- High yield corporate bonds fell -1.16% as credit spreads widened, up 43 basis points in the high yield market. Leveraged loans were nearly flat for the month at 0.01%, leading longer-duration bonds.
- Multiple listed real asset markets were down in October with the Wilshire Global Real Estate Securities Index<sup>™</sup> returning -4.64% and the FTSE Global Core Infrastructure Index down -1.70%.
- Commodities, as measured by the Bloomberg Commodity Index, were up 0.27% in October.
