Monthly Market Commentary

Month Ended December 31, 2024

U.S. Economy and Markets

- The broad U.S. equity market was down for the month as the FT Wilshire 5000 IndexSM returned -3.03%, with a positive return of 23.76% for the year-to-date.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap IndexSM and the FT Wilshire Small Cap IndexSM returning -2.38% and -7.42%, respectively.
- Performance across GICS sectors was mostly negative for the quarter. Energy and materials were the main market laggards while communication services and consumer discretionary were the main market leaders for the quarter.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned -2.27% in December. The MSCI Emerging Markets Index also produced a loss during the month, down -0.14%.
- Economic growth in England continues to slow with business confidence waning. Prospects in Germany, Europe's largest economy, are equally dim due to persistently high energy prices and growing competition with China.

Fixed Income & Real Assets

- The U.S Treasury yield curve was up across most of the maturity spectrum during the quarter. The 10-year Treasury yield ended December at 4.57%, up 79 basis points from September.
- Credit spreads were down modestly during the quarter with high yield bond spreads down -8 basis points, to end the quarter below 3%. High yield corporate bonds were down -0.43% for the month. Leveraged loans were up for the month at 0.57%, leading longer-duration bonds.
- Multiple listed real asset markets were down for the month with The Wilshire Global Real Estate Securities IndexSM returning -7.25% and the FTSE Global Core Infrastructure Index down -5.77%.
- Commodities, as measured by the Bloomberg Commodity Index, were up 1.02% in December.

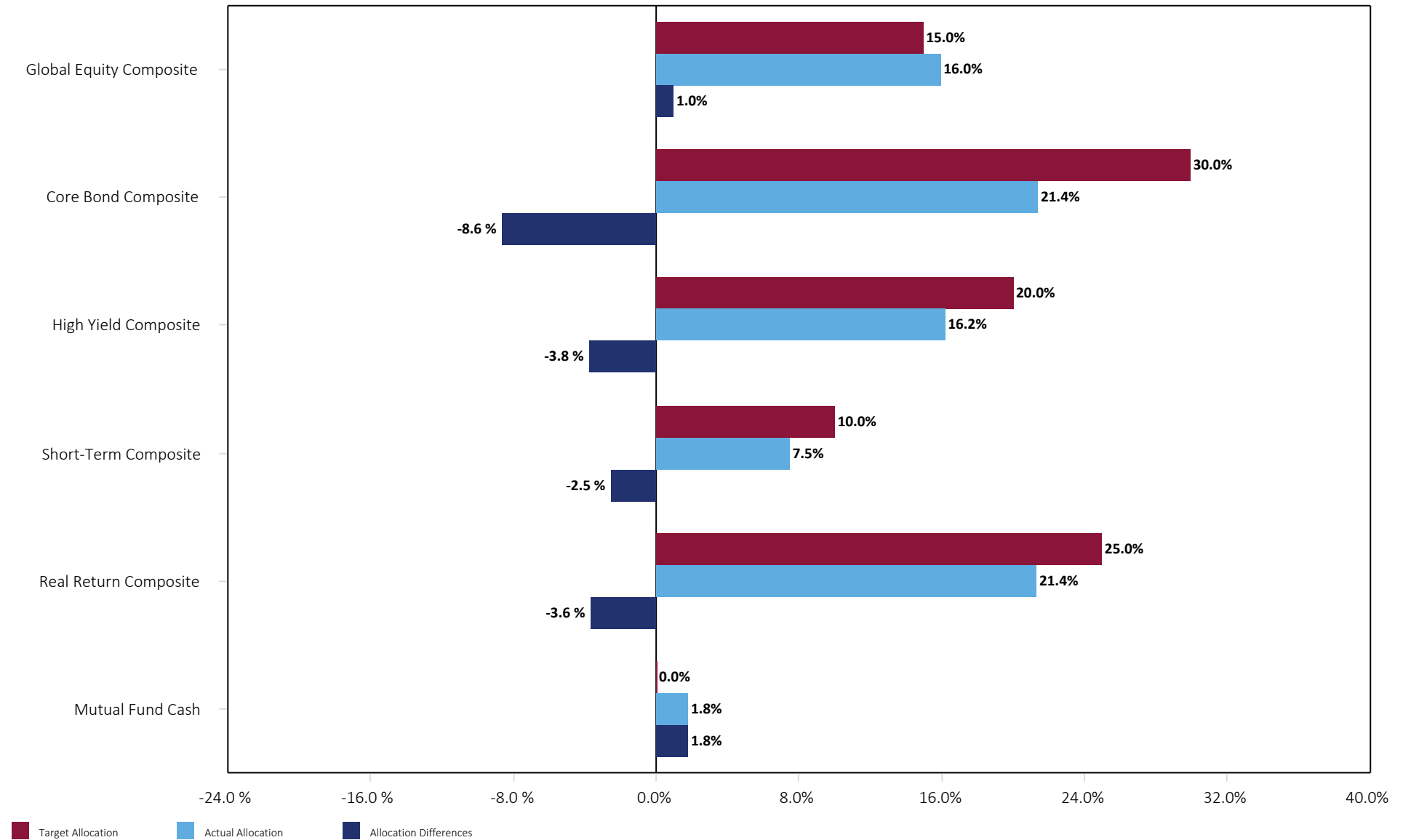
