Monthly Market Commentary

Month Ended April 30, 2025

U.S. Economy and Markets

- The broad U.S. equity market was down in April as the FT Wilshire 5000 IndexSM returned -0.66%, with a positive return of 11.26% for the past 12 months.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap IndexSM and the FT Wilshire Small Cap IndexSM returning -0.40% and -2.43%, respectively.
- Performance across GICS sectors was mixed during April. Information technology and consumer staples were up for the month while energy stocks sold-off, with smaller losses in health care and real estate.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned 4.58% this month. The MSCI Emerging Markets Index also produced a gain in April, up 1.31%.
- The U.S. dollar weakened versus advanced foreign economies during the month, resulting in the developed markets local currency return being lower than those converted back to dollars.

Fixed Income & Real Assets

- Core bonds posted a gain of 0.39% in April as the 10-year U.S. Treasury yield fell 5 basis points.
- High yield corporate bonds were down -0.02% as credit spreads were up for the month, by 37 basis points in the high yield market. Leveraged loans were down for the month at -0.05%, roughly equal to longer-duration bonds.
- Multiple listed real asset markets were down in April with The Wilshire Global Real Estate Securities IndexSM returning -0.65%, while the FTSE Global Core Infrastructure Index was up 1.72%.
- Commodities, as measured by the Bloomberg Commodity Index, were negative at -4.81% in April.

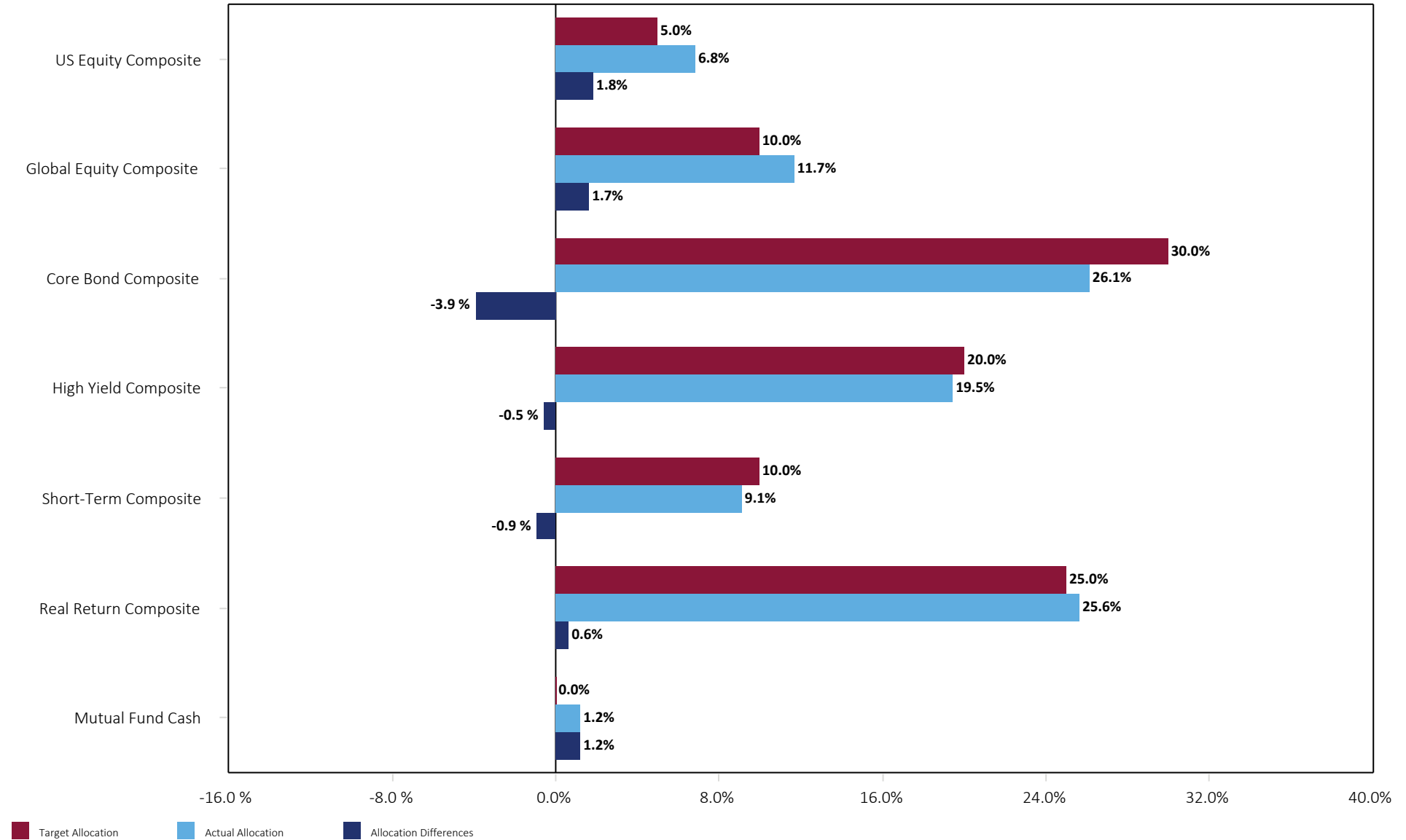
