Monthly Market Commentary

Month Ended June 30, 2025

U.S. Economy and Markets

- The broad U.S. equity market was up in June as the FT Wilshire 5000 IndexSM returned 5.12%, with a return of 11.11% for the second quarter.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap IndexSM and the FT Wilshire Small Cap IndexSM returning 5.25% and 3.86%, respectively.
- Performance across GICS sectors was mostly positive during June. Information technology was the best performing sector while energy and health care were the main market laggards.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned 2.20% this month. The MSCI Emerging Markets Index also produced a gain in June, up 6.01%.
- Currency changes played a major role in U.S. dollar returns this quarter as the dollar fell meaningfully versus the euro, pound and yen.

Fixed Income & Real Assets

- The U.S. Treasury yield curve was down among intermediate maturities during the quarter but up for longer maturities starting at 10 years. The 10-year Treasury yield ended the quarter at 4.23%, up just two basis points from March. Core bonds posted a gain of 1.54% for the month.
- Credit spreads were down noticeably during the quarter with high-yield bond spreads down 57 basis points, to end the quarter at 2.90%, which is very close to the level that existed to start the year.
- High yield corporate bonds were up 1.84% for the month. Leveraged loans were also up for the month at 0.80%, trailing longer duration bonds.
- Multiple listed real asset markets were up in June with The Wilshire Global Real Estate Securities IndexSM returning 0.46%, while the FTSE Global Core Infrastructure Index was up 1.00%.
- Commodities, as measured by the Bloomberg Commodity Index, were positive at 2.41% in June.

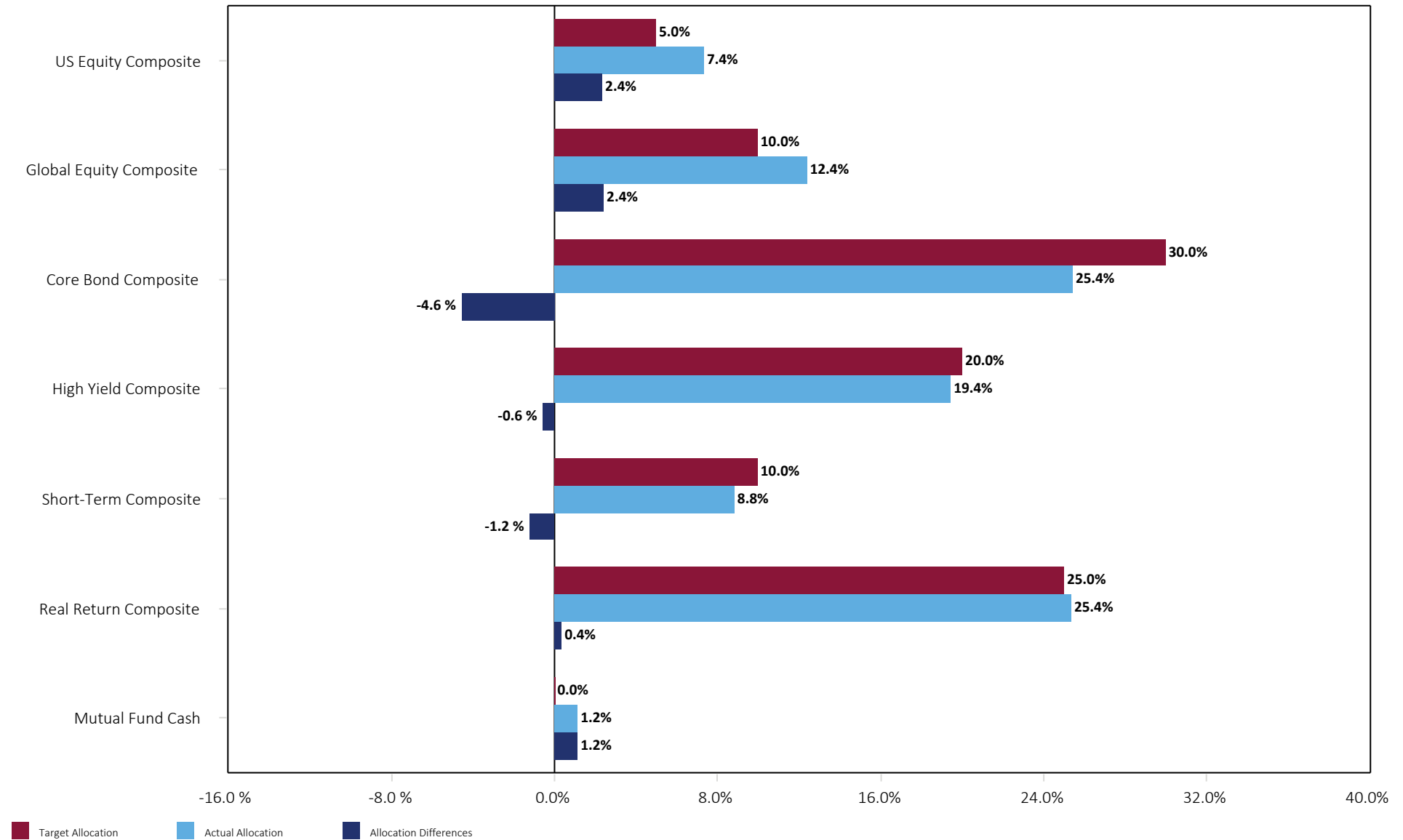
