Market Commentary

Month Ended December 31 2025

U.S. Economy and Markets

- The broad U.S. equity market was down in December as the FT Wilshire 5000 IndexSM returned -0.07%, with a return of 17.13% for the past 12 months.
- Large-cap stocks underperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap IndexSM and the FT Wilshire Small Cap IndexSM returning -0.08% and -0.03%, respectively.
- Performance across GICS sectors was mixed during December. Health care and communication were the best performing sectors for the month while real estate and utilities were the main laggards.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned 3.00% this month. The MSCI Emerging Markets Index produced a gain in December, up 2.99%.
- Performance results within international equity markets were positive for the month, although U.S. dollar-based returns were hampered by weakening foreign currencies.

Fixed Income & Real Assets

- Core bonds posted a loss of -0.15% in December as the 10-year U.S. Treasury yield rose 2 basis points.
- High yield corporate bonds were up 0.57% as credit spreads were down for the month, by 19 basis points in the high yield market. Leveraged loans were up for the month at 0.64%, above longer-duration bonds.
- Listed real asset markets were down in December with the Wilshire Global Real Estate Securities IndexSM returning -1.50% and the FTSE Global Core Infrastructure Index down -1.63%.
- Commodities, as measured by the Bloomberg Commodity Index, were negative at -0.32% in December.

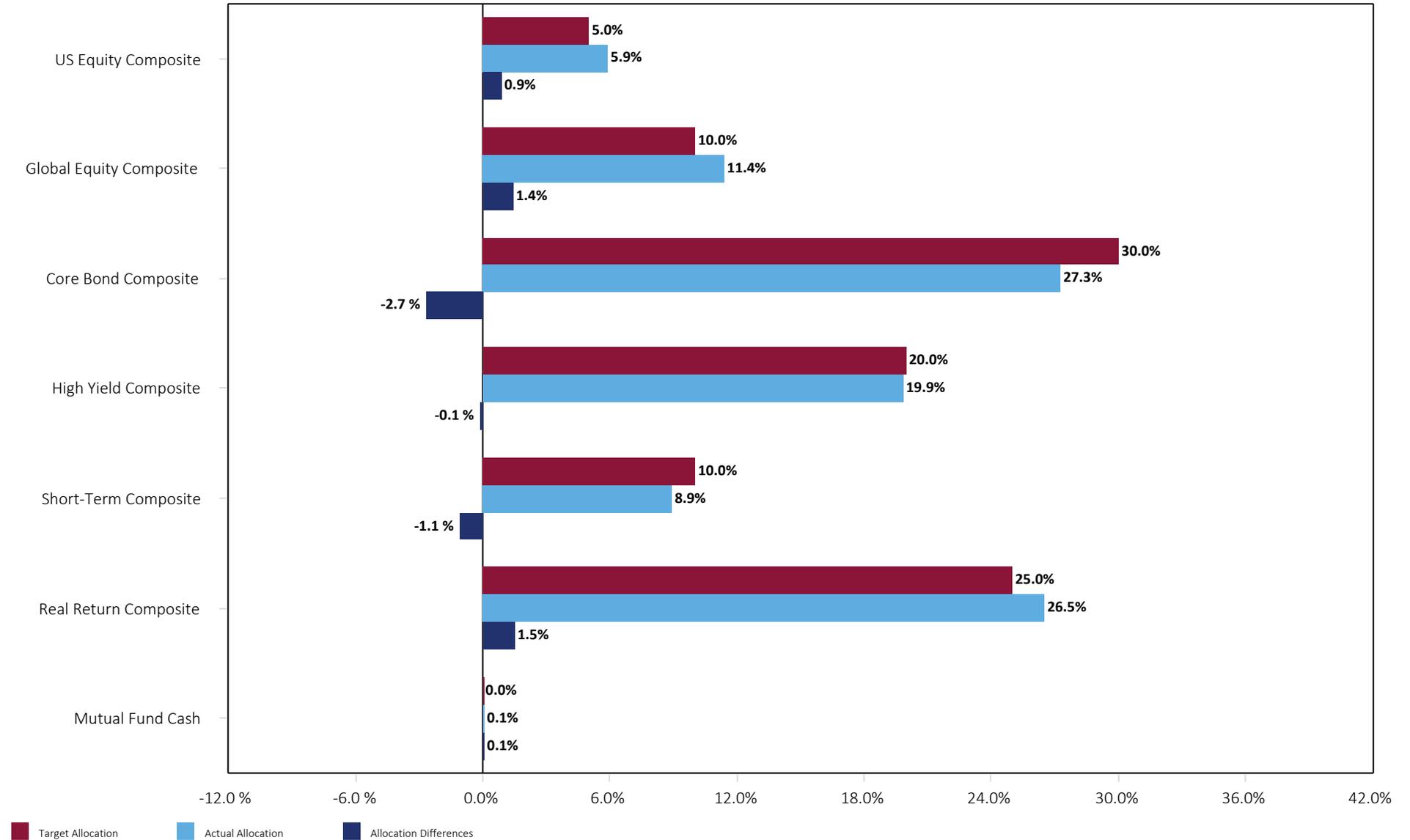
